Chairperson Peschong: opens the floor for public comment, seeing none, closes public comment and brings the item back to the Board for further discussion.

Treasurer Hamon: asks for clarification on the \$136,485 listed under Eligible Additional Grant Funds.

City Staff, Dick McKinley: replies that the \$136,485 is the difference between the “not to exceed” contract amount and the \$1.5 million grant amount, adding that the \$136,485 could be spent right now with full reimbursement through the grant process.

Chairperson Peschong: comments that during this process, more public comments have been received on Chapter 9 than at any other point over the last five years, adding that it could be a good expenditure to do additional community engagement, at least on Chapter 9.

City Staff, Dick McKinley: comments that staff is not asking for the Board to detail out the negotiation and engagement process but is asking the Board for direction to do this on their behalf; an overview of this process is explained.

Treasurer Hamon: makes a motion to receive and file the Budget Report including, but not to exceed, the \$136,485 amount.

Chairperson Peschong: seconds the motions and asks for comments from the Board.

County Staff, Courtney Howard: provides a Project Status Update on the Paso Basin GSP development schedule and responds to a question from Chairperson Peschong, confirming the close of the public comment period for Draft Chapters 9-12 and Appendices H, I and K will be July 1st.

City Staff, Dick McKinley: reiterates that public comments can be submitted via the pasogcp.com comment portal.

County Staff, Courtney Howard: provides a Project Status Update on the Subsidence Analysis Overview, including the current estimated cost of the screening analysis being \$95,000 with a potential for federal cost sharing of \$9,500—resulting in a current estimated total cost \$85,500.

Chairperson Peschong: shares his support for the subsidence analysis and asks for additional input from the Board.

County Staff, Courtney Howard: replies that as part of the GSP implementation, this would be seen in Chapter 10 as one of the data gaps to fill after adoption, adding there is no current timeline.

City Staff, Dick McKinley: concurs that the analysis would be conducted after the GSP has been submitted.

Treasurer Hamon: asks if the partner agencies would be responsible for costs associated with the study since the GSP would already have been submitted to DWR.

City Staff, Dick McKinley: replies yes, adding that the Plan identifies data gaps, and over time, those data gaps will be addressed.

Chairperson Peschong: opens the floor for public comment.

Dennis Loucks, Patricia Wilmore, and Greg Grewal: speak.

Chairperson Peschong: closes public comment and asks staff if tabling the item for further deliberation would interfere with any existing timelines.

County Staff, Courtney Howard: clarifies that the data showing the degree of subsidence already exists, and that analyzing the data to determine the cause of subsidence is the data gap to fill; sees no issue tabling the item to a later date.
