Rx Opioid Abuse Report Card

Prescription drug abuse has become one of the fastest growing public health concerns in the United States. Today, drug overdoses kill more than cars, guns, and falling. Prescription drug abuse crosses all boundaries — gender, ethnicity, economic status, and age. Because all sectors of society are impacted, solutions will require integrated community-wide approaches.

The SLO County Opioid Safety Coalition was established in 2016 to reduce prescription drug misuse and abuse. A kick-off event was held on January 21, 2016 as a call-to-action. The Initiative is driven by a diverse coalition of community members, including among others: law enforcement, physicians, pharmacists, treatment professionals, Public Health Department, Behavioral Health Department, and educators. These community members make up five action teams: Data Collection and Monitoring; Safe Prescribing and Health Care; Medication Assisted Treatment; Community Prevention and First Responders; and Naloxone: Overdose Antidote. All will work to collaboratively address the problem in San Luis Obispo County.
