

S.E. Acquisition of Los Osos Mortuary and Memorial Park, Inc (dba Los Osos Valley Memorial Park; "Memorial Park") submits this appeal to the San Luis Obispo County Board of Supervisors in regards to an action of the Planning Commission approving a Development Plan/Coastal Development Permit ("CDP") for the Los Osos Wastewater Project ("Sewer Plant") and certifying the Final Environmental Impact Report (FEIR).

Memorial Park operates a dedicated cemetery on property located adjacent to the proposed Sewer Plant. Memorial Park objects to the Planning Commission's decision to locate the Sewer Plant on the Giacomazzi Property. The Sewer Plant should be located at the Tonini site, as was initially recommended by the Public Works Department and the initial proposed FEIR.

Memorial Park's primary concern with the Giacomazzi location relates to the negative impact that it will have on the maintenance and operation of the existing dedicated cemetery. State policy protects dedicated cemeteries against interference. For example, provisions of California's Health and Safety Code prohibits the exercise of eminent domain to construct public thorough fares or utilities across a dedicated cemetery (see sections 8560 and 8560.5) and cemeteries are exempt from certain assessments (see section 8561). The courts have noted that it has long been the policy of this State to protect places where the dead are buried against interference (*Eden Memorial Park v. Superior Court of Los Angeles* (1961) 189 Cal.App.2d 421, 424. The *Eden* decision, quoting from section 8559, noted that the dedication of land for cemetery purposes "shall be deemed to be in respect for the dead, a provision for the interment of human remains, and a duty to, and for the benefit or, the *general public*".

The placement of the Sewer Plant adjacent to the cemetery will interfere with the tranquil and restful ambiance of the cemetery. People attending outdoor burial services at the cemetery do so at difficult and stressful periods in their lives. Also, visitors to grave sites come to pay their respects and to grieve. The cemetery should provide a pleasant and accepting environment for both burials and visitations. The impact of the Sewer Plant on the unique aspects of the cemetery environment affects the public at large because it is a place for the public to respect and dignify the dead.

The Planning Commission's decision to locate the Sewer Plant to the Giacomazzi Property does not properly take into account the adverse impacts to the cemetery. The Draft EIR and the Final EIR do not properly analyze the impacts of the Sewer Plant on the cemetery, nor the special significance of this use. The proposed Sewer Plant is an incompatible use as to the cemetery, yet there is has been neither analysis nor conclusions that address this incompatibility. The incompatibility in use is inconsistent with applicable land use regulation and basic planning principles.

Also, the Planning Commission's decision did not adequately consider positive aspects of the Preferred Project alternative at the Tonini site, nor negative aspects of the Giacomazzi site.

This appeal is a general statement of Memorial Park's position regarding the Planning Commission's decision. Memorial Park will provide supplemental information supporting its grounds for this appeal.
