**A RESOLUTION OF THE WORKFORCE DEVELOPMENT BOARD EXECUTIVE COMMITTEE  
ACKNOWLEDGING  
THE COUNTY OF SAN LUIS OBISPO'S PROCLAMATION OF A STATE OF EMERGENCY AND  
AUTHORIZING MEETINGS BY TELECONFERENCE MEETINGS FOR A PERIOD OF  
THIRTY DAYS PURSUANT TO THE RALPH M. BROWN ACT**

The following resolution is now offered and read:

WHEREAS, on January 09, 2023, the County of San Luis Obispo issued a Proclamation of State of Emergency in response to a natural disaster; and

WHEREAS, the proclaimed state of emergency remains in effect; and

WHEREAS, on September 16, 2021, Governor Newsom signed AB 361, allowing legislative bodies subject to the Brown Act to continue meeting by teleconference if the legislative body determines that meeting in person would present imminent risks to the health or safety of attendees, and further requires that certain findings be made by the legislative body every thirty (30) days; and

WHEREAS, in the interest of public health and safety, as affected by the emergency caused by the natural disaster, the Workforce Development Board Executive Committee deems it necessary to find holding in person meetings would present imminent risks to the health or safety of attendees, and thus intends to invoke the provisions of AB 361 related to teleconferencing.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED by the Workforce Development Board Executive Committee that:

1. The recitals set forth above are true and correct.
2. The Proclamation of State of Emergency in response to the natural disaster issued by the County of San Luis Obispo on January 09, 2023, remains in effect.
3. Based on the recitals above, the Workforce Development Board Executive Committee finds that meeting in person would present imminent risks to the health or safety of attendees.
