1	While the standard treatment fees are calculated and based on the cost of doing business, clients are assessed a fee based on their ability to pay. The ability to pay is calculated based on a sliding fee scale or the Uniform Method of Determining Ability to Pay (UMDAP), taking into consideration factors such as household income and the number of dependents in the household.
2	FC 16601 receives Medi-Cal reimbursement based on actual costs or published rate, whichever is lower. To ensure that the actual costs can be reimbursed, and not limited to the published rate, the rates are inflated. Proposed units of service have not been included on this worksheet since the calculated revenue projection would be overstated due to the inflated rates.
3	FC 16602 receives Drug Medi-Cal reimbursement based on actual costs or published rate, whichever is lower. To ensure that the actual costs can be reimbursed, and not limited to the published rate, the rates are inflated. Proposed units of service have not been included on this worksheet since the calculated revenue projection would be overstated due to the inflated rates.
