

Mr. Buckshi:

The City of Pismo Beach commends the County of San Luis Obispo for taking the lead on investigating the use of the Pacific Gas and Electric (PG&E) Desalination Plant as a potential water supply for the Zone 3 agencies and possibly other regions of San Luis Obispo County. A long term sustainable drought proof source of water is needed by our region to ensure our prosperity for generations to come. As you are aware, the City of Pismo Beach is pursuing a recycled water project at our wastewater treatment plant that is projected to deliver approximately 675 acre-feet (AF) of potable water to the South County through indirect potable reuse. Should the State regulations change, our project is anticipated to be able to deliver approximately 850 AF of direct reuse potable water.

Our City is very interested in investigating how desalinated water may be able to complement our current efforts and we encourage the County to continue its pursuit of delivering desalinated water from PG&E's plant. Clearly there are many factors that we need to consider before committing to the project, such as: cost per AF, contract terms and conditions, anticipated delivery date and how this project will affect the City's other interests.

Letter of Interest Regarding the Zone 3 Emergency Water Supply Project

Dear Mr. Horton:

The City of Grover Beach is in receipt of your letter dated October 15, 2015 requesting confirmation of the City's interest in the Zone 3 Emergency Water Supply Project. It is our understanding that the project would involve the delivery into the Zone 3 distribution system of up to an estimated 1,000 acre feet per year of desalinated sea water from PG&E's treatment facility, located next to the Diablo Canyon Power Plant. It is also our understanding that the San Luis Obispo County Flood Control District (District) is evaluating the feasibility of this project at the present time.

Following Council discussion at the November 30, 2015 and December 7, 2015 meetings, the City Council authorized sending a letter to the District confirming our interest in the project and to encourage the District to advance the project. Please be aware that ultimate support and participation by the City of Grover Beach will be dependent on project costs and an evaluation of water source priorities of the City. As you continue with this process, we would encourage the District to pursue grant and loan opportunities for the project in order to limit cost impacts to the potential participants.

We appreciate the District's leadership in developing this project as a possible contributor to solving the drought conditions in the South County. However, please recognize the City's need to look at and vet all water source opportunities as they present themselves.

Subject: Diablo Desalination Feasibility Study

Mr. Horton,

The purpose of this letter is to reply to your request for an understanding of the interest that the Oceano Community Services District (OCSD) may have in participating in a water supply project from the Diablo desalination facilities (Diablo). On August 12, 2015, the OCSD Board of Directors considered the status of the County's efforts in evaluating the feasibility of a supply from Diablo and expressed overall support for those efforts. The Board also expressed concerns on the cost implications. Additional consideration by the Board will be possible once a project update can be provided with cost and delivery details.

A specific point of interest is whether the project might be implemented through existing Zone 3 (Lopez) water supply contracts. The current water year for the Lopez project is the first in its history that has seen a reduction in deliveries. Since the Diablo supply can improve the reliability of the Lopez project, and will utilize the Zone 3 conveyance system, consideration for doing so under the existing Lopez contracts, with appropriate amendments, would be the preference of OCSD. Understandably this approach will best be accomplished if all the Zone 3 participating agencies choose to participate in the Diablo project utilizing the same water allocation percentages. Although it is premature to make such determination, OCSD would hope that the County will consider this contracting approach.
