1	Short Term Oversized Vehicle Parking Fee is a minimum daily charge, and may be subject to increase dependent upon size of vehicle. The fee may be set higher for higher impact vehicles.
2	Annual Parking Permit is issued for a 12 month period, and not per calendar year. Permit is not prorated.
4	Please reference San Luis Obispo County Airport Website at www.sloairport.com for current San Luis Obispo Airport Hangar Rates
5	Application fee is non-refundable and due with application submittal. Additional fees may apply for impacts, excess County staff hours, encroachment permits, FAA review, or extended term of permit on a case basis.
6	Discount may be negotiated by Director of Airports for government assigned employees. Please see current badge instructions, requirements, and training schedule at www.sloairport.com .
7	Restrictions apply. Camping is limited to pilots approved to fly into airport.
8	Periodic Increase may apply per individual rental agreement.
9	Discount representing upto 100% reduction may be issued by the Director of Airports, with an official appeal or application for discount.
10	Stated Rate for Ground Rent - Aircraft Storage (Oceano) is a minimum rate. Rate will fluctuate depending on facility size and other factors.
11	Ground Transportation Networks are charged for both the drop off and the pick up. Each trip is charged separately.
12	Badge Renewal Fee is charged upon badge expiration and renewal. Renewal frequency varies depending on badge type. Frequency is annual or biennial (once every two years), depending on badge type. Any badge expired more than 30 days is dropped out of the security system by the Transportation Security Administration, and the customer will be subject to the first time badge fee.
