Footnote #	Footnote Narrative
1	The proposed fee structure and amounts are based on California Business and Professions Code section 12240 which states "...the board of supervisors, by ordinance, may charge an annual registration fee, not to exceed the county's total cost of actually inspecting or testing the devices as required by law, to recover the costs of inspecting or testing weighing and measuring devices required of the county sealer pursuant to Section 12210, and to recover the cost of carrying out Section 12211." The proposed fees are at or below the levels specified in statute for the second year of a three-year graduated implementation schedule commencing January 1, 2006. For FY 09/10, the projected total costs of the device program is \$326,783. The proposed FY 09/10 device registration revenue is \$166,942, or 51.1% of the projected cost.
2	If an application is submitted within six months of the pre-application meeting, 50% of the pre-application fees will be applied towards application processing fees.
