Group Counseling		\$24.00	Each	Fees charged to clients varies based on the client's ability to pay using a sliding fee scale. Fee increase due to increased labor and overhead costs.
Client Assessment		\$285.00	Each	Fee increase a result of change to labor calculation to more accurately reflect direct services time.
Returned Check		\$33.00	Each	Set by Treasurer
Absence Fee		\$24.00	Each	Cost charged for failure to attend scheduled meeting. Fee set same as a group meeting charge. Fee increase due to increased labor and overhead costs.
Patch Test Fee		\$65.00	Each	Patch drug test is used as an alternative to the normal urine testing for clients who are unable to test frequently. Fee increase due to increased labor and overhead costs. Decreased units of services reflect FY 07-08 actuals.
Urine Testing		\$27.00	Each	Cost of administering urine drug test. Fee increase due to increased labor and overhead costs.
Urine Testing (EtG Test)		\$41.00	Each	Urine test used strictly to determine the presence of alcohol in the system. Fee increase due to increased labor and overhead costs. Increased units of services reflect FY 07-08 actuals.

Reinstatement		\$77.00	Each	Fee to process a reinstatement for a client to re-enter a program. Fee increase due to increased labor and overhead costs.
Transfer-in/out processing fee		\$77.00	Each	Process fee to perform a transfer in/out from/to another County. Fee increase due to increased labor and overhead costs.
Session Charge		\$32.00	Each	Charge for services performed. Session fee averages both individual and group counseling sessions. Increase does not reclaim full cost due to sufficient fund balance.
Missed Meeting Charge		\$32.00	Each	Cost charged for failure to show to scheduled meeting. Increase does not reclaim full cost due to sufficient fund balance.
Notice of Completion		\$19.00	Each	Fee to process a notice of completion to DMV. Fee decrease due to change to electronic submission resulting in decreased processing time.
Leave of Absence Fee		\$45.00	Each	Fee to process a leave of absence from any DUI program. Includes cost to reinstate. Fee increase due to increased labor costs.
Urine Testing		\$27.00	Each	Administrative addition to make Fund Center 162 and 375 consistent for UA fee.

<b>Footnote #</b>	<b>Footnote Narrative</b>
1	While the standard treatment fees are calculated and based on the cost of doing businesses, clients are assessed a fee based on their ability to pay. The ability to pay is calculated based on a sliding fee scale, taking into consideration factors such as household income and the number of dependents in the household.
