**RESOLUTION COMMENDING ED GOSHORN FOR HIS SERVICE AS CHAIR ON  
THE BICYCLE ADVISORY COMMITTEE IN SAN LUIS OBISPO COUNTY**

The following resolution is hereby offered and read:

**WHEREAS**, Ed Goshorn stepped down in November 2005 after serving for two years as chair of the Bicycle Advisory Committee; and

**WHEREAS**, Ed has served as committee chair three separate occasions and has been a member of the Bicycle Advisory Committee since its inception on February 9, 1993, when he was its first chair; and

**WHEREAS**, Ed molded a diverse group of cycling advocates into an effective and cooperative committee to draft the county's first Bikeways Plan; and

**WHEREAS**, During his most recent tenure as Bicycle Advisory Committee chair, Ed oversaw preparation and dedication of the Colin Reilly bridge across Old Creek in Cayucos and dedication of the Bob Garing Bike Lanes on Foothill Road; oversaw committee work with Parks and Recreation to include bike trails in the PRE element of the general plan; successfully recommended that County staff adopt uniform materials and design standard for Class I bikeways designed by subdivisions; and oversaw the most recent update of the County Bikeways Plan; and

**WHEREAS**, Ed recently retired from teaching junior high and high school science for 34 years (26 years at Atascadero Junior High School); and

**WHEREAS**, Ed is a dedicated cyclist who has not only ridden countless recreational miles on county roads for nearly three decades but also has ridden more than 65,000 miles commuting daily to and from school and providing to his students a model for the use of alternative transportation; and

**WHEREAS**, Ed has also completed many notable one day cycling events, including twenty-seven double centuries throughout California and both the Lighthouse and Wildflower centuries more times than he can remember.

**NOW, THEREFORE, BE IT RESOLVED AND ORDERED** that the Board of Supervisors of the County of San Luis Obispo, State of California, does hereby Commend Ed Goshorn for his dedication to the Bicycling Advisory Committee and thanks him for all the volunteer hours spent improving the bicycling experience for everyone in San Luis Obispo County.
