Bonno Kroeze started working for the Department of Parks and Beaches in late 1974. By the time of his retirement in 2005 he had risen to the rank of Ranger III.

Bonno served as a hands-on supervisor and was well liked and respected by his peers. Throughout his 31 years of service Bono worked for many supervisors and managers with all giving him accolades for his work performance and dedication to duty.
