RESOLUTION PROCLAIMING MAY 2006 AS BIKE MONTH AND
MAY 15 - 19, 2006 AS "BIKE TO WORK AND SCHOOL WEEK"
IN SAN LUIS OBISPO COUNTY

The following resolution is hereby offered and read:

WHEREAS, bicycle commuting is an effective means to reduce air pollution and conserve energy and promotes the "livability" of communities by reducing traffic, noise and congestion; and

WHEREAS, many businesses, organizations and schools have made efforts to help customers, students and employees commute by bicycle, including installation of bicycle parking and other commute facilities; and

WHEREAS, bicycle transportation is an integral part of the "multi-modal" transportation systems planned by federal, state, regional, and local transportation agencies; and

WHEREAS, bike month is a San Luis Obispo County-wide celebration of human powered transportation which encourages people of all ages and abilities to ride bicycles to their destinations; and

WHEREAS, bike month promotions such as "Bike-to-Work and School Week", "Commuter Bike Challenge", "Executive Commuter Bike Challenge" and "Bike Fest 2006" successfully encourages citizens to ride their bicycles, thereby reducing vehicular emissions in the county; and

WHEREAS, "Bikes in Bloom" is the theme for 2006, an appropriate notion as this area is in bloom with cycling groups who are working together and individually to support bicycling in all of its forms in San Luis Obispo County; and

WHEREAS, businesses are encouraged to take part in the "Bike Art Display" by decorating their company's window in the "Bikes in Bloom" theme throughout the month of May.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors, County of San Luis Obispo, State of California, does hereby proclaim May 2006 as "Bike Month" and May 15 - 19, 2006 as "Bike to Work and School Week".
