## Recommendations

It is our recommendations that your Honorable Board:

1. Approve the resolution confirming the 2006-07 County Service Area No. 21, Ashby Lane Road Improvement Zone special tax rate of \$8.96 per front foot of improvement per parcel having a separate County Assessor's Parcel Number and increasing not more than two percent per year thereafter.
2. Direct the Clerk to file the approved copy of the Resolution with the County Auditor no later than August 10, 2006.

## Discussion

On May 8, 2001, the electorate in County Service Area No. 21, Ashby Lane Road Improvement Zone voted for approval of a special tax with a maximum annual rate of Twenty Three (\$23.00) per front foot of improvement per parcel having a separate County Assessor's Parcel Number and increasing not more than two percent per year thereafter. Fiscal Year 2006-07 will be the third year that the tax will be levied. No further consideration due to Proposition 218 is required.

In order to levy the tax during the 2006-07 fiscal year, your Honorable Board must pass a Resolution establishing the 2006-07 rate, and confirming the amount of the special tax levied on each parcel of real property. The special tax is authorized per Section 53978 of the Government Code.

### **Other Agency Involvement/Impact**

County Counsel has reviewed the subject Resolution and approved it as to legal form and effect. The Offices of the Auditor-Controller and Treasurer/Tax Collector are involved in the process of collecting special taxes on the property tax bills. The County Clerk will file the resolution with the Auditor-Controller.

### **Financial Considerations**

The recommended action will generate approximately \$6,700 in revenue, which will fund the annual loan debt payment to the General Fund. The loan funded the paving of Ashby Lane Road.

### **Results**

This action will provide sufficient funding to repay the loan from the General Fund. The funds being paid back were originally used to pave Ashby Lane Road in Cambria. This has enhanced the quality of life for those participating in the project, and contributed to a safe and prosperous community.



### RESOLUTION TO ESTABLISH 2006-07 SPECIAL TAX IN COUNTY SERVICE AREA NO. 21 ASHBY LANE ROAD IMPROVEMENT ZONE

The following Resolution is hereby offered and read:

Resolution to set special taxes for road improvements in Cambria.

**WHEREAS**, County Service Area No. 21, Ashby Lane Road Improvement Zone, has need to have special taxes levied therein for the 2006-07 fiscal year to cover the costs of providing road improvements within said district; and

**WHEREAS**, Section 53978 of the California Government Code provides for such special taxes to be levied upon each parcel of real property within said district for such purposes, provided that an election is first held in said district upon the question of whether such special tax should be levied; and

**WHEREAS**, the voters of said district, on May 8, 2001 by an 87% majority vote of those voting on the issue approved the levying of a special tax within said district for the Fiscal Year 2001-02 and continuously thereafter for said purposes, providing said special tax does not exceed Twenty Three (\$23.00) per front foot of improvement per parcel having a separate County Assessor's Parcel Number and increasing not more than two percent per year thereafter.

**NOW, THEREFORE, BE IT RESOLVED AND ORDERED** the Board of Supervisors of San Luis Obispo, State of California, sitting as the Governing Board of County Service Area No. 21, Ashby Lane Road Improvement as follows:

1. That the recitals set forth hereinabove are true, correct and valid.
2. That the special tax rate for 2006-07 is hereby set within said Ashby Lane Road Improvement Zone at \$8.96 per front foot of improvement per parcel having a separate County Assessor's Parcel Number.
3. That the special tax on the parcels of real property in County Service Area No. 21, Ashby Lane Road Improvement Zone, shall be and are hereby established imposed and levied in the amounts set forth on Exhibit "A" which is hereby attached hereto and incorporated herein by reference as though here fully set forth.
