RESOLUTION RECOGNIZING JAMES M. MASSEY FOR 33 YEARS OF
DEDICATED SERVICE TO THE GOVERNOR'S OFFICE OF EMERGENCY SERVICES**

The following resolution is hereby offered and read:

WHEREAS, James M. Massey was born in Rowan County North Carolina, June 29, 1924;
and

WHEREAS, James M. Massey was married on August 24, 1946 to his wife Peggy Massey
for 52 years, until her passing on November 14, 2002; and

WHEREAS, James M. Massey served in the United States Army from February 25, 1943
to July 1, 1973, serving in World War II, the Korean War, and Viet Nam; and

WHEREAS, James M. Massey, while serving in the Philippines during World War II,
earned both the Silver Star for Gallantry in Action, and the Bronze Star for Heroic and
Meritorious Achievement, and was personally decorated with the Silver Star by General Douglas
Mac Arthur; and

WHEREAS, while serving in Korea, James M. Massey earned that Country's highest
honor, the Legion of Merit, for "Exceptionally Meritorious Conduct"; and

WHEREAS, since 1973, James M. Massey has served as the "first and only" Range
Master for the Officer Safety Course at the California Specialized Training Institute (CSTI); and

WHEREAS, James M. Massey has worked continuously at CSTI from July 1973 to July
2006, serving the State of California for 33 years, and improving the skills and safety awareness
of thousands of law enforcement personnel.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that the Board of Supervisors
of the County of San Luis Obispo, State of California, does hereby Recognize James M. Massey
for his 33 years of dedicated service to the Governor's Office of Emergency Services.
