**RESOLUTION RECOGNIZING CHAPLAIN JUDY BOEN FOR RECEIVING THE
COMMISSION ON THE STATUS OF WOMEN 2006 "SERVICE TO WOMEN" AWARD**

The following resolution is hereby offered and read:

WHEREAS, The San Luis Obispo County Commission on the Status of Women has chosen Chaplain Judy Boen to receive its 2006 Service to Women Award. The Commission is honoring Boen for her continuing and tireless efforts assisting women who are battling addictions and other problematic life choices; and

WHEREAS, Judy Boen is the founder and executive director of Captive Heart Ministries, which opened its doors in March 2000 and is based in the Five Cities area; and

WHEREAS, Judy Boen presently serves as the Chaplain of the San Luis Obispo County Women's Jail and Sheriff's Department and has completed the Sheriff's Citizen Academy; and

WHEREAS, Born in Paso Robles, Judy Boen has spent many years in prison ministry, including a period as chaplain at a state prison in Oklahoma counseling women on death row; and

WHEREAS, Over the past two years Judy Boen has opened two sober living/recovery environmental homes with education in Nipomo and Arroyo Grande which housed six women and a house manager each, and were a six-month to a year residential program that focuses on helping women beat their addiction and break their continual self-destructive cycles; and

WHEREAS, Judy Boen is the author of *Roots That Affect Our Lives*, a Christian 12-Step Program, and she leads classes, seminars, and conferences.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that the Board of Supervisors of the County of San Luis Obispo, State of California, does hereby Recognize Chaplain Judy Boen for receiving the Commission on the Status of Women 2006 "Service to Women" Award.
