Jan 4* – Feb 25	Petition in lieu of filing fee period (EC 8106)
Feb 1	Semi Annual Campaign Statement Filing Deadline (Gov Code 84200, 84218)
Feb 1 – Feb 10th	Declaration of Intention period for Judicial Candidates (EC8023)
Feb 11- Feb 15*	Extension of Declaration of Intention period for Judicial Candidates (Non-Incumbents only.) (EC8023)
Feb 15* – Mar 12th	Nomination Period. Incumbents must file by March 12 th at 5:00 PM. (EC 8070, 8082) Please call the Elections Division at 781-5228 to make an appointment.
Mar 13 - Mar 17^{th**}	Extension of Nomination Period (Non-Incumbents Only) (EC 8022 & 8024) DOES NOT APPLY WHERE THERE IS NO INCUMBENT DUE TO TERM LIMITS (8022)
Mar 15	Last Day to withdraw Candidate Statement of Qualifications by 5:00PM for races closing March 12 th (EC 13307(a)(3))
Mar 18	Last Day to withdraw Candidate Statement of Qualifications by 5:00PM for races closing March 17 th (EC 13307(a)(3))
Mar 22	Filing Deadline. Pre-Election Campaign Statement (Gov Code 84200.5, 84200.7(a))
Apr 12 – May 25th	Write-In Candidate Period (EC 8601)
May 10	29 Day Close of Registration - First day Vote by Mail Ballots are available - Last day to register to vote in order to receive a Sample Ballot & State Ballot Pamphlet (EC 3001, 3003)
May 24	15 Day Close of Registration - Voters registering between May 10 th & 24 th will receive notification of their polling place, but will not receive any other voter information. (EC 2102, 2107)
May 27	Filing Deadline - Pre-Election Campaign Statement (Gov Code 84200.5, 84200.7(a)) First Day to begin counting vote-by-mail ballots
June 1	Last day for Elections Office to mail Vote by Mail Ballots to voters. (EC 3001) After this date, a voter must appear in person to receive a ballot.
June 8	Election Day. Polls open at 7:00am. Polls close at 8:00pm.
June 30	Filing Deadline – Semi-Annual Campaign Statement, Due 7-31-2010.
July 6	Complete Official Canvass.

* If a filing deadline falls on a weekend or a holiday, it is moved to the next business day.

** If an eligible incumbent fails to file by the deadline, a five day extension period is allowed for any person other than the incumbent to file.
