Any and all cost for transportation, handling, loading, inspection, etc. are the responsibility of the Buyer, at the Buyer's sole cost and expense. The Buyer shall assume full responsibility and all liability associated with the removal of items bought.
3. Unless otherwise definitely specified, the prices quoted are net to the County of San Luis Obispo and **do not** included California Sales Taxes. If property is not for resale, 8.25% California Sales Tax will be added to bid prices. Sales taxes must be paid to Seller by Buyer unless a Certificate of Resale or Sales Tax Permit number is furnished or submitted on request.
4. All bids must be submitted on the attached form and must be fully signed. Unsigned bids **will not** be considered. All information shall be entered in ink or typewritten. Mistakes may be corrected prior to submission of the bid by crossing out the error and initialing the change in ink. Corrections and/or modifications received after the closing time specified **will not** be accepted
5. Payment shall be by cash, certified or cashiers check, or money order. **Personal checks will not be accepted.**
6. All items must be paid for and picked up between September 22, 2010 and October 20, 2010.
7. In the event of identical bids, award shall be decided by the flip of a coin.
