You are hereby notified of the following additional information and instruction for the RSOQ #1204-12, which shall take precedence over anything to the contrary therein. The Contractor shall acknowledge receipt of this and all addenda.

The following questions were submitted via e-mail. Responses are provided.

1. QUESTION: *Part VI, Attachment 1 – Certificate of Accountant* - What are you requesting in this certificate?

RESPONSE: Provide a copy of the CPA license indicating current status as described in Section 1, Item D. on Page 7 of 64.

2. QUESTION: Part IV, Item c. (Page 57 of 64) references "private or government" projects. Is it the intent of this reference to exclude such projects as publicly funded higher educational projects? Or should the reference be Public/Government projects as indicated in Part IV.A.1. (on Page 25 of 64)?

RESPONSE: Part IV.A.1. refers to "... at least three (3) public/government bid projects..." and Part IV, Item c. references "private or government" project experience. Part IV, Item c. includes both private and public projects meeting specified requirements (i.e. \$30,000,000, etc.), which would include as publicly funded higher educational projects.

3. QUESTION: *Part IV, Item h. (Page 58 of 64)* - Is it the intent of this requirement to place greater emphasis on "working together" than maximum project experience?

RESPONSE: The intent of the question is to ensure that the proposed Project Manager and Field Superintendent have worked together previously on a similar project.

Please note the following change to Request for Statement of Qualifications (RSOQ) # 1204-12. All changes shall be incorporated in and become part of the respective RSOQ.

- Page 15, Part II, Item 2. should read as follows: *Contractor has a liability insurance policy with a policy limit of at least \$5,000,000 per occurrence, \$10,000,000 aggregate, and 30,000,000 excess umbrella policy.*
- **Applications for Prequalification for General Contractors are now due on February 6, 2013 by 5:00 p.m. (PST).** Note that the deadline for Applications for Prequalification for **Sub-Contractors** remains January 30, 2013 by 5:00 p.m. (PST).

Any proposer who has already submitted the RSOQ and desires to make corrections or changes may request the RSOQ be returned. If corrections are made, a new or revised RSOQ must be received at the Office of the General Services Agency, 1087 Santa Rosa Street, San Luis Obispo, California, 93408, by February 6, 2013 by 5:00 p.m. (PST).
