1. Please note the following changes to Request for Proposals (RFP) PS-#1217-13. All changes shall be incorporated in and become part of the respective RFP.
 - Delete the following strike-through text and add the following underlined text to Page 4, Item A.5.:

Will assign a ~~full time~~ manager to this project **to manage all commissioning activities included in contract**, other than the Principal-in-Charge.
 - Delete the following strikethrough text and add the following underlined text to Page 4, Item A.5.e.:

The Cx PM must remain on the project **during actual commissioning activities contracted with the County of San Luis Obispo** until Notice of Completion is issued.
 - Add the following underlined text to Page 1, paragraph 1:

The County of San Luis Obispo (County) is currently soliciting Request for Proposals for professional consultant services for RFP-#1217-13 COMMISSIONING AGENT SERVICES FOR SHERIFF-COC-EXPAND WOMEN'S JAIL, 300034. **The County reserves the right to use the current RFP process and eligible consultants for Commissioning Services when considering a consultant to provide similar services for, Probation-COC-Juvenile Hall Expansion, 320032.**
 - Add the following underlined text to Page 4., Item A.2.:

Has provided **design or** commissioning services, for at least two (2) correctional facilities with construction budgets greater than \$15 million, within the last 10 years. Projects must be At least substantially complete. At least one of the two projects shall be a jail with a minimum 100 bed capacity.

- Add the following underlined text to Page 4., Item A.5.b.:

The Cx PM must have managed or be currently managing the commissioning efforts for at least one ~~corrections~~ **institutional** facility **with designated secured areas.**
For purposes of this RFP, institutional facilities with designated secured areas are limited to correctional, hospital, medical or military.

2. RFP PS-#1217-13 will be opened as originally scheduled at 3:00 p.m. on June 25, 2013. Any proposer who has already submitted the Request For Proposals and desires to make corrections or changes may request the submittal be returned. If corrections are made, a new or revised RFP must be received at the Office of the General Services Agency, 1087 Santa Rosa Street, San Luis Obispo, California, 93408, by the TIME AND HOUR STATED IN THIS PARAGRAPH.
3. All other specifications, provisions, and conditions remain unchanged.
