5. **Presentation:** CalMHSA Suicide Prevention Grant –Barry Johnson and Jill Bolster-White (T-MHA) gave a brief presentation of the Suicide Prevention Grant which includes: suicide prevention, reduce suicide, outreach, and resources, and to be able to bring “SLO the Stigma Campaign” to the Veterans. The grant is to expand services to Kern County and Santa Barbara County.

6. Presentation – Board Of Supervisors Meetings – David Riester

David Riester, Mary Lee Waggoner, Karl Hansen and Tyler Brown met with all 5 members of the BOS (individually) on Monday June 6th. The goal was to advocate for saving the positions that had been cut from Martha's Place due to the budget cuts. David presented the Supervisors with the Mental Health Annual Report. David, Mary Lee, Karl and Tyler said all the meetings were informative and are glad that they had spent the time with each Supervisor.

7. Presentation: Public Guardian, Lisa Niesen describes what and how the Public Guardian process works.

- The selection of a conservator is solely in the hands of the Court.
- An L.P.S. conservatorship is for a person who is gravely disabled (as the result of a mental disorder) and is unable to provide for his/her basic needs. An L.P.S. conservatorship must be renewed by the conservator on an annual basis.
- Probate conservatorship provides a way to manage property and/or provide for the personal care needs of the adult disabled and the elderly. A probate conservatorship may be of the person only, or estate only, or person and estate combined.
- Payee program: individuals who have difficulty managing money or their financial affairs may qualify to have the Office of the Public Guardian serve as their Representative Payee.
- The establishment of a conservatorship has three basic effect:
 1. It shifts the responsibility of making financial and personal care decisions from the disabled individual (the conservatee) to the Court appointed manager (the conservator).
 2. It imposes significant limitations on the ability of the conservatee to take actions affecting finances or personal care.
 3. It provides a certain degree of protection for the conservatee's interests from fraud, misappropriation of funds or neglect.
- The Office of the Public Guardian is the agency designated to investigate the need for both Probate and L.P.S. Public Guardian conservatorships.

- Budget hearings – The issue of AB 3632 mandate remains unresolved.
- State update, no approved budget yet.
- AB109 authorizes the transfer of thousands of state prisoners to local jails, away from the state and down to the county level. The AB109 will not take effect until the state has figured out a way to pay counties for the extra responsibilities. No funding yet.
- 130 inmates will be transferred into our jail within the next 3 years. In anticipation of receiving these additional 130 inmates due to the realignment the Sheriff's Office has formed a committee to evaluate the existing facility in
