MINUTES

1. Call to Order

President Bergman called the meeting to order at 9:00 A.M. and led the flag salute.

2. Public Comment Period

President Bergman addressed the audience asking for anyone wishing to speak to the Commission during the Public Comment Period on any matter that is not listed on today's agenda. Being none, the public comment period was closed.

3. Hearing - Open Session: Appeal #A08-117, dated September 19, 2008 Appellant Carrie Bisterfeldt

President Bergman called the hearing to order and introduced Appeal #08-117. Ms. Duke informed the Commission that there were corrections to the agenda packet that needed to be made before proceeding. After both parties agreed that the revisions were acceptable President Bergman directed the clerk to distribute the revised exhibits to the Commission. President Bergman excused all witnesses from the room and called both parties forward to proceed with the hearing. Tom Bordonaro, County Assessor stated that he is the respondent and is being assisted by Barbara Edginton, Assessment Manger. Christine Brown, SLOCEA, stated that she is representing the appellant, Carrie Bisterfeldt.

Mr. Bordonaro and Ms. Brown presented their opening statements respectively. Mr. Bordonaro called Barbara Edginton, Assessment Manager, as his first witness. At the conclusion of Mr. Bordonaro's questioning, Ms. Brown questioned Ms. Edginton. After responding to additional questions from both parties, she responded to questions from the Commission. Ms. Edginton was then excused as a witness.

Mr. Bordonaro called his second witness Mary Ann Hess, Supervising Property Transfer Technician. Upon completion of Mr. Bordonaro's questioning, Ms. Brown questioned Ms. Hess. After responding to additional questions from both parties, she responded to questions from the Commission. Ms. Hess was then excused as a witness.
