SUBJECT: ROAD NAME REQUIREMENTS

It has been determined that you have a parcel/dwelling located on a road that does not have a road name. As part of implementing the county's 911 Emergency Response System, and as a result of new fire regulations going into effect, all roads that are not officially named must be named through the Department of Planning and Building. A road name is important for the emergency dispatcher so that sheriff, fire and ambulance vehicles can respond most efficiently in the event of an emergency.

The following is from adopted county codes:

Title 20 – Road Name and Address Ordinance – 20.03.014 – Road Name Required: A road name shall be required for all unnamed roads that provide vehicular access to more than one legal lot of record or to one lot of record with more than two buildings or four or more dwelling units. Road naming shall occur either prior to a land division map being recorded, or prior to final building inspection being granted, or in conjunction with an application from the property owner.

The above ordinance requirement became effective on September 21, 1991 and applies to all single family residences and businesses. It is important that the application attached to this letter be filled out and returned with the appropriate fee(s). An additional fee for manufacturing and delivery of the road sign will be required. A private vendor must be contacted to provide this service.


Title 20 – Section 20.03.018 – Road Name Selection

Road names shall be based on the following criteria:


- a. **Duplicate Road Names.** Road names shall not duplicate another road name used elsewhere in the unincorporated areas of the county or in an incorporated city. Similar sounding names are considered duplicate regardless of spelling.
- b. **Family Names.** Roads shall not be named after a family surname unless it can be proven in writing to the satisfaction of the Department of Planning and Building that the surname is one of historical prominence in the area of the road to be named.
- c. **Language.** Road names in either English or a foreign language shall be grammatically correct and easy to pronounce and spell and shall not include the use of slang or profanity.
- d. **Road Name Length.** Road names shall be of a length to fit on a 36 inch sign blade (approximately 18 letters).
- e. **Road Type Classification.** Road names shall include the appropriate road classification as set forth below:




STREET NAME SIGN BRACKET DETAILS

RURAL CONDITIONS




URBAN CONDITIONS

STREET SIGN PLACEMENT DETAIL


NOTES:

1. STREET NAME SIGN BLADES TO BE EXTRUDED ALUMINUM, 6063-T6 ALLOY, DEGREASED AND ETCHED WITH GREEN SCOTCHLITE APPLIED TO BOTH SURFACES.
2. POST-TO-SIGN BRACKET TO BE DIE-CAST, #360 ALLOY WITH TWO ANGLED GUSSETS EACH SIDE FOR STRENGTH. TO FIT 2-3/8" O.D. GALVANIZED PIPE (2" I.D.). SIGN-TO-SIGN BRACKET TO BE SIMILAR CONSTRUCTION WITH 90° AND 45° SEPARATION.
3. CAPITAL LETTERS TO BE DIE-CUT SILVER SCOTCHLITE, SERIES B.
4. SCREWS FOR SECURING BRACKETS TO BE ZINC PLATED HEX SOCKET HEAD SCREWS 1/4"x1/2".
5. SIGN SADDLE BRACKET TO BE EXTRUDED ALUMINUM, TO FIT 2-3/8" O.D. PIPE, FASTEN WITH A VANDAL PROOF NUT SET (HAWKINS TRAFFIC M2G-S2S, OR APPROVED EQUAL).


