WHAT'S BEING PROPOSED: The Urban County prepared a summary of draft recommendations for the 2016 Action Plan pursuant to the requirements of the U.S. Department of Housing and Urban Development. The Action Plan describes activities proposed for funding through the 2016 Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME), and Emergency Solutions Grant (ESG) programs.
