



WHEREAS the diesel emissions from trains along the route would generate toxic pollutants that exceed medically advised thresholds and cause cancer, heart disease, and asthma in an area that is the third highest for childhood asthma disorders in the state of California;

WHEREAS at a meeting on March 3, 2015, students and teachers encouraged the San Lorenzo Unified School District Board to pass this resolution in opposition of trains carrying crude oil, passing through our community and thereby putting into danger the precious lives of our students and teachers;

THEREFORE, BE IT RESOLVED that the San Lorenzo Unified School District requests that the County Board of Supervisors of San Luis Obispo County deny permits for the Phillips 66 oil train offloading facility and the denial of any construction related to this project.


