





**Statement to San Luis Obispo County Planning Commission
Professor Jonathan Reich, Cal Poly**

February 5th, 2016

Hello and Thank you for your great patience and work on the planning commission.
My Name is Jonathan Reich.

I am an architect, and a professor of Architecture here at Cal Poly

where for 14 years I have taught our national and state award winning courses on sustainable environments.

I am a Fulbright Scholar, sent by the US Department of State to teach sustainable design in Europe.

I am also one of the very few architects certified by the State of California Office of Regulations Services (formerly the Office of the State Architect) as a public school construction inspector.

I am dedicated to education, to sustainable design, which obviously includes safety and preservation of our lives.

It was troubling yesterday to hear the attorney for Phillips 66, Jocelyn Thompson, try to tell you that you have little authority in this matter, to condescendingly belittle your knowledge and expertise, and belittle the great knowledge and expertise of so many of the great variety of people you've heard from yesterday and today, by saying in effect that there are smarter people elsewhere taking care of our safety and concerns, and that we should not worry.

It was troubling to hear the attorney try to bully and intimidate you and us by saying "if no trains, we'll get trucks."

They tried to assure us of their safety record and that safety matters to them.

But the odds and in fact history says otherwise.

Phillips 66 has this last year been fined \$11.5 million, on charges of improper disposal of harmful waste material and the companies have agreed to pay the charged fines to the State of California.

About 2 weeks ago, Phillips 66 Ferndale, WA refinery was fined \$324,000 for violations in workplace safety and health related to fires and hazardous chemicals.

These are cases where they were caught.

What about rail safety?

Three days ago, a Union Pacific train derailed in Pocatello Idaho.

Please visit the "DOT-111 Reader" website to see the collection of news stories about the almost weekly train derailments that occur nationally.

The nearby Refugio oil pipeline break spilled approximately 142,800 gallons of oil, only 1/15th of the amount of oil EACH oil train will carry through our community.

Exxon is being investigated by several states attorney generals for hiding the research of their own scientists for decades which confirmed the evidence that use of fossil fuels contributed to global climate change, and instead funded climate change deniers in a concerted effort to confuse the public and law makers.

My now teenage son was born about 100 yards from the rail line here in town.

He will attend high school about 100 yards from the rail line here in town. I teach about 100 yards from the tracks.

According to the research and the EIR, approval of the Phillips 66 rail spur would put all our lives at risk.

My wife and I saved for our whole lives to buy a modest home here in town where we could be biking distance from our work, shopping, and our son's schooling, but about 3/4 mile from the tracks.

Now we are being asked to see our home's value, and every other homeowner's home value in town,

Our lives and health all diminished by being in the so-called "blast zone" of these new oil trains.

Why would we suffer this risk and loss of quality of our lives?

So some corporation in Texas can make more profit.

The money made by the Phillips 66 oil spur will leave the state and go to Houston Texas.

Make no mistake. This is only about money.

In fact the only people who support this proposal are either being paid by Phillips 66 or hope to be paid by Phillips 66. This is only about more profit for Phillips 66.

And everyone who has spoken against this proposal has spoken from a standpoint of facts, science, laws and legal principle, concern for the environment, or fear for their own safety, well-being, and sustainability of our lives.

I urge you to not approve the applicant's, Phillips 66, project before you.

Your excellent staff has given you excellent guidance. There are MANY reasons to deny this project.

You have the historic authority and opportunity to do the right thing here; legally, for our community, and for the state and the nation.




