Subject: Hwy 58 - Quarry proposal

Please DO NOT approve a quarry operation on Hwy 58. There are MANY reasons this would be COMPLETELY DETRIMENTAL to all residents effected.

Impact study MUST at minimum involve:

HOW MANY residents would this business effect?

Property value decline - how many residents would lose significant property values due to NOISE from blasting, ROAD/TRAFFIC CONDITIONS, DUST, not to mention HIGH RISK OF LOSING THEIR WELL WATER with 20,000 gallons a day!!

Property values would PLUMMET PERMANENTLY if this is passed. WHERE IS THE JUSTICE HERE?

HWY 58 has a TRUCK ADVISORY -- TRUCKS ARE ADVISED TO USE ANOTHER ROUTE. There are NO TURNOUTS, it is a VERY WINDY, two lane road and allowing 200 trucks a day on it would CAUSE SIGNIFICANT ISSUES WITH RESIDENTS COMMUTE TIMES. THIS IS UNACCEPTABLE. SO WHAT TIMES WOULD THESE TRUCKS BE ON THE ROAD? THIS WILL CAUSE FATALITIES. Motorcyclists use Hwy 58 at high speeds, pass on double yellows. There is NO DOUBT people will lose their lives if there are 200 trucks on this road a day. NO DOUBT!

If this passes, HWY 58 MUST BE COMPLETELY REDONE WITH TURNOUTS and PASSING LANES. HIGH COSTS TO TAX PAYERS -- NOT ACCEPTABLE!

Biggest concern is property value loss and risk of loss of well water to all residents living along the entire stretch of Hwy 58 and beyond. This is frankly TOO MUCH RISK to APPROVE this proposal!!

We moved to this area for one reason: PEACE AND QUIET -- a quarry operation with blasting would RUIN the one reason we invested in a home. Not only that, we would have a difficult time selling our home to anyone with a quarry nearby and the detrimental effects from well water running dry or too low, NOISE, DUST, TRAFFIC etc..NOT ACCEPTABLE!!!!
