Proposed Negative Declarations

A Negative Declaration is issued for projects that would not result in significant effects on the environment. In many cases, the project applicant has added mitigation measures to the project to reduce environmental impacts in order to qualify for a Negative Declaration. If you disagree with the issuance of a proposed Negative Declaration, you may provide comments or file a Request for Review (appeal) of the Negative Declaration. Requests for Review must be filed within two weeks of the date that the proposed Negative Declaration is posted and must address only environmental issues. There is a fee for the request. Shandon-Carrizo Area

California Serengeti Corporation for a Minor Use Permit. Request to allow for the remodel of an existing motel at west side of the Soda Lake Road and the addition of 30 free standing cabins with covered parking around the motel. The project also includes the refurbishment of two existing fast food pre-manufactured buildings and relocation to east side of the Soda Lake Road along with improved parking areas for the proposed fast food restaurant, existing convenience store and sit-down restaurant. Project is located at 12900 Soda Lake Road, approximately 0.25 miles north of the California Valley fire station and library, in the Shandon-Carrizo planning area. ED11-166 (DRC2011-00055)

Paso Robles Area

Jardine Minor Use Permit. Request by Mary Jardine for a 1.0-mega watt solar generation facility on a 10-acre portion of a 64.36-acre site. The project is located at 910 Nacimiento Lake Drive in Paso Robles in the Adelaida planning area. ED11-082 (DRC2011-00040)
