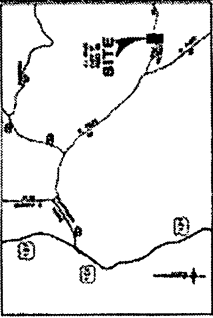

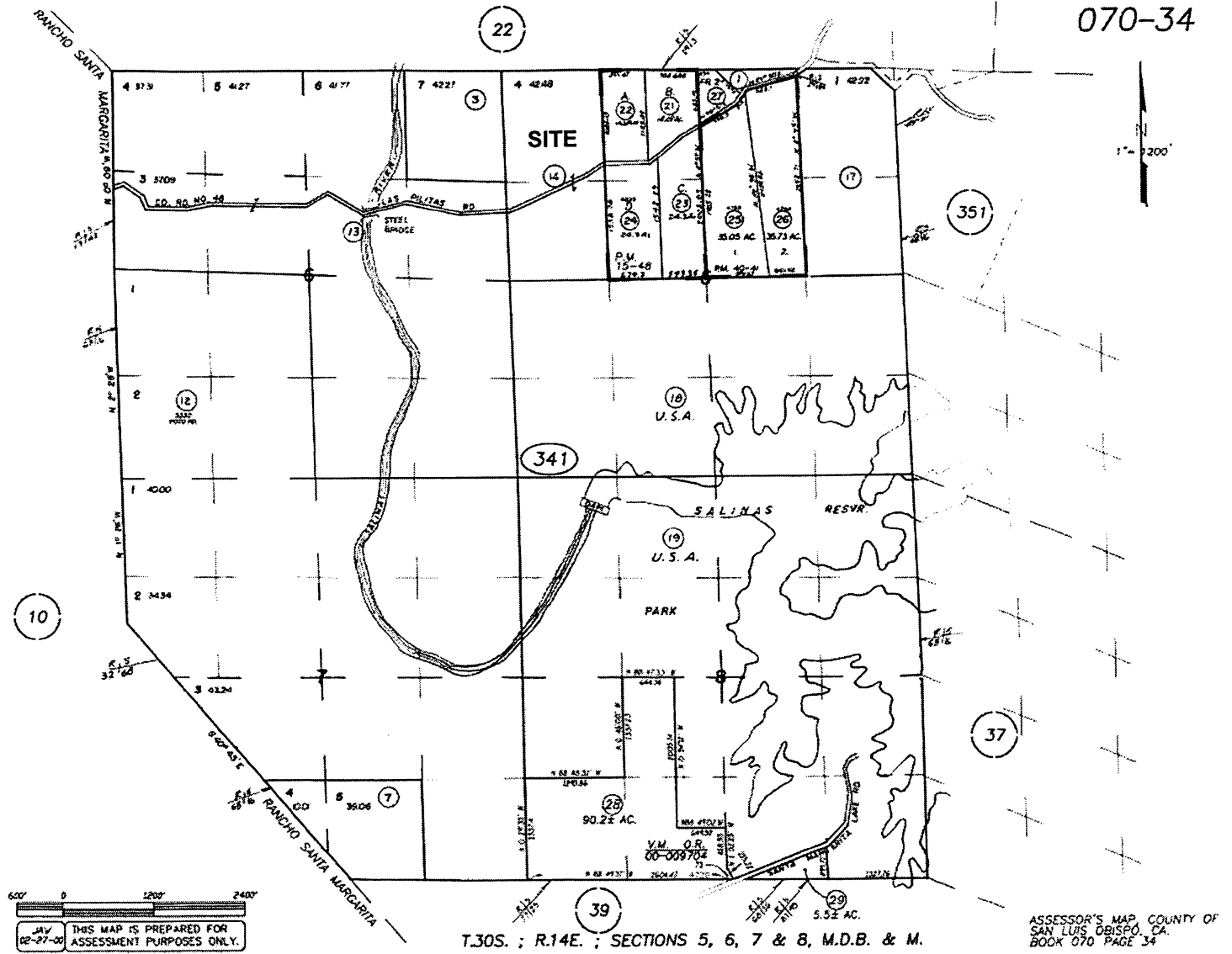

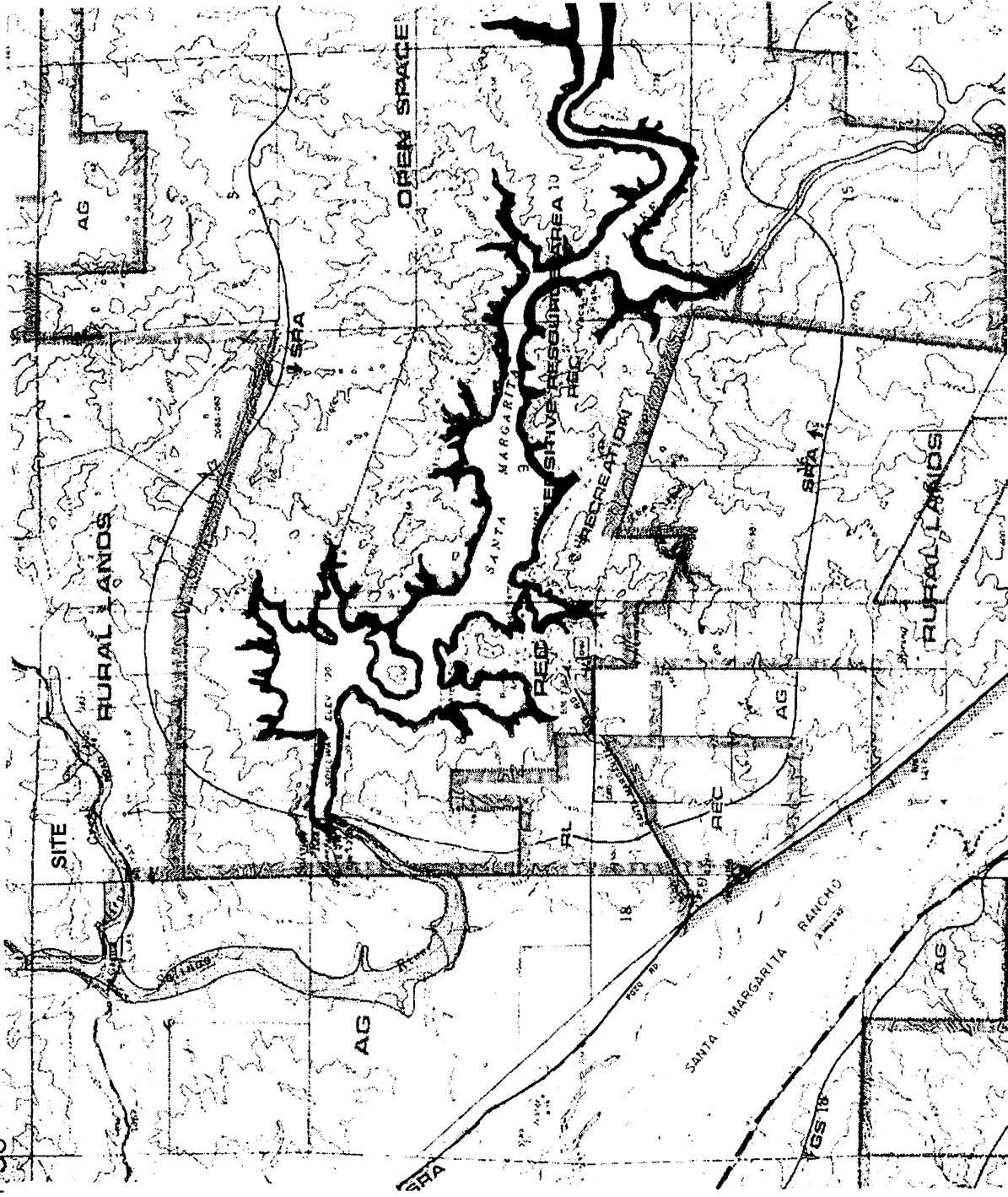

 Assessors Parcel Map



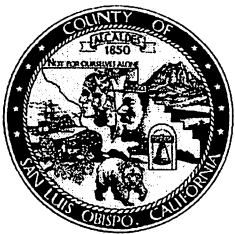
