ADDENDUM TO NOTICE OF ASSESSMENT

SAN LUIS OBISPO COUNTY WASTEWATER ASSESSMENT DISTRICT NO. 1 COUNTY OF SAN LUIS OBISPO

On February 27, 2008, an Assessment Diagram (the "Assessment Diagram") and a Notice of Assessment (the "Notice of Assessment") were recorded in the records of the County Recorder of the County of San Luis Obispo with respect to the assessments levied on certain parcels situated within the San Luis Obispo County Wastewater Assessment District No. 1 (the "Assessment District"). Specifically, the Assessment Diagram is recorded at Book 5 of Maps of Assessment and Community Facilities Districts, at pages 32 through 72, inclusive, and the Notice of Assessment is recorded as Document No. 2008009552. Exhibit A attached to the Notice of Assessment lists the parcels of land within the Assessment District, together with the amount of the assessment levied on each such parcel, and the identity of each such parcel is cross-referenced to the assessment number as shown on the Assessment Diagram.

NOTICE IS HEREBY GIVEN that this Addendum to the Notice of Assessment (this "Addendum") is being recorded in accordance with Section 3114.3 of the Streets and Highways Code for two purposes, namely:

1. to state that the **amount of the assessment** on each of the parcels listed in Exhibit A, attached hereto and by this reference incorporated herein, **has been reduced** from the original assessment amount to the reduced amount set forth in said Exhibit A; and
2. to state that the full amount of the original assessment has been prepaid and **the lien has been and is hereby fully discharged and released** for each of the parcels listed in Exhibit B, attached hereto and by this reference incorporated herein.

NOTICE IS FURTHER GIVEN that, upon the recording of this Addendum in the official records of the County Recorder of San Luis Obispo County, the assessment lien previously established on each parcel listed in Exhibit B hereto shall be deemed to be and the same hereby is fully discharged and released and of no further force or effect for any purpose whatsoever.
