
The aboveground facilities for the mid-town pump station shall be re-located to Palisades Avenue (south of the Library) on APN 074-229-017.

**Evidence of compliance:**

The only above-ground features of the Midtown pump station at the southwest corner of the Midtown site will be three electrical boxes (addressed in evidence of compliance for Condition 51).

The generator building for this pump stations will be constructed at the northeast corner of the Midtown parcel, just north of the South Bay Library (PS-C-204). The change in generator location from the Los Osos Community Park to the library site was approved by the Coastal Commission via immaterial amendment on March 8, 2012.

**Original CDP Approval**

CDP A-3-SLO-09-055/069 was originally approved by the Coastal Commission on June 11, 2010, and it authorized the construction and operation of a community sewer system (including a treatment plant, collection/disposal/reuse facilities, and all associated development and infrastructure) in the unincorporated coastal community of Los Osos adjacent to Morro Bay in central San Luis Obispo County (with the treatment plant located at 2198 Los Osos Valley Road and other related infrastructure located throughout Los Osos).

**CDP Amendment**

CDP A-3-SLO-09-055/069 is amended to allow the generator building associated with the Midtown pump station facility to be relocated from Los Osos Community Park to the parking lot area of the Los Osos branch of the San Luis Obispo County Library system.

**Coastal Commission Concurrence**

This amendment was determined by the Executive Director to be immaterial, was duly noticed, and no objections were received and/or the Commission concurred with the Executive Director's determination of immateriality. This amendment will become effective upon return of a signed copy of this form to the Central Coast District Office. Please note that the CDP terms and conditions, including as modified by this amendment and/or previous amendments if applicable, remain in effect.
