The County's elected representatives and employees are committed to serve the community with pride to enhance the economic, environmental, and social quality of life in San Luis Obispo County.

CAYUCOS NEWS

The Cayucos CSA 10 Water Distribution System Improvement project is complete. This project will supply the residents of CSA 10A with fire flows able to meet California Fire Code requirements. These upgrades included upsizing 3,800 linear feet of undersized 4-inch distribution waterlines in south Cayucos, to 8-inch pipeline.

A project to construct a new water storage tank is in the permitting stage, which includes a lengthy Coastal Commission approval process. Construction of the tank is anticipated to be complete in 2016.

On January 17, 2014, the Governor declared a drought emergency for all of California. The State is requesting a voluntary 20% reduction in water usage. The County will be working with individual water communities to meet this goal.

SOURCES OF DRINKING WATER AND YOUR WATER SUPPLY

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- *Microbial contaminants*, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- *Inorganic contaminants*, such as salts and metals, which can be naturally occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- *Pesticides and herbicides*, which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses.
- *Organic chemical contaminants*, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems.
- *Radioactive contaminants* which can be naturally occurring or be the result of oil and gas production and mining activities.

To ensure that tap water is safe to drink, the United States Environmental Protection Agency (USEPA) and the California Department of Public Health (CDPH) prescribe regulations which limit the amount of certain contaminants in water provided by public water systems. CDPH regulations also establish limits for contaminants in bottled water that provide the same protection for public health.

The primary source of water for Cayucos is Whale Rock Reservoir. Whale Rock Reservoir has a total capacity of 40,660 acre-feet. The reservoir is managed by the Whale Rock Commission comprised of the City of San Luis Obispo,

KEY TERMS and ABBREVIATIONS

CU - color units

CFU/mL—number of colony forming units per milliliter of sample

LRAA (Locational Running Annual Average) – .An arithmetic average is computed quarterly for each site and compliance is based on the running average of quarters.

MCL (Maximum Contaminant Level) – The highest level of a contaminant that is allowed in drinking water.

MCLG (Maximum Contaminant Level Goal) - The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs are set by the United States Environmental Protection Agency.

MRDL (Maximum Residual Disinfectant Level) - The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

MRDLG (Maximum Residual Disinfectant Level Goal) - The level of a disinfectant added for water treatment below which there is no known or expected risk to health. MRDLGs are set by the U.S. Environmental Protection Agency.

ND (Not Detected) - Contaminant is not detectable at testing limit.

NL (Notification Level) – The concentration of a contaminant that, if exceeded, triggers treatment or other requirement which a water system must follow.

NS (No Standard) - Contaminant for which there is no established MCL.

NTU - Nephelometric Turbidity Unit

pCi/L - picoCuries per liter (a measure of radioactivity)

PHG (Public Health Goal) – The level of a contaminant in drinking water below which there is no known or expected risk to health. PHGs are set by the California Environmental Protection Agency.

ppb - parts per billion, or micrograms per liter (µg/L)

ppm - parts per million, or milligrams per liter (mg/L)

Primary Drinking Water Standards – MCLs and MRDLs for contaminants that affect health along with their monitoring and reporting requirements, and water treatment requirements.

Secondary Drinking Water Standards – MCLs for contaminants to protect the taste, odor, or appearance of the drinking water.

TON - Threshold Odor Number

TT (Treatment Technique) – A required process intended to reduce the level of a contaminant in drinking water.

µS/cm— microSiemens per centimeter (1 S = 1 ohm⁻¹) A measure of electrical conductance.

DRINKING WATER AND HEALTH RISKS

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. **The presence of contaminants does not necessarily indicate that water poses a health risk.** More information about contaminants and potential health effects can be obtained by calling the USEPA’s Safe Drinking Water Hotline (1-800-426-4791).

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDs or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. The USEPA/ Centers for Disease Control (CDC) guidelines on appropriate means to lessen the risk of infection by Cryptosporidium and other microbial contaminants are available from the Safe Drinking Water Hotline (1-800-426-4791).

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water typically comes from materials and components associated with service lines and home plumbing.

The County of San Luis Obispo is responsible for providing high quality drinking water, but cannot control the variety of materials used in household plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. OPERATIONS

The Cayucos water system is assigned three primary operators who, like all operators who work for the County, are certified by the California Department of Public Health (CDPH). Our operators are knowledgeable professionals who have many years of experience. They are dedicated to maintaining an excellent water system and providing you with the best quality water possible.

Operators conduct weekly inspections of the well, tank, and distribution system to ensure a safe and reliable water supply. In addition, the CDPH routinely inspects the facilities, operating procedures, and water quality monitoring records to verify compliance with state and federal regulatory requirements.



the California Men’s Colony, and Cal Poly. No swimming or other body contact sports are allowed on the reservoir in order to minimize viral contamination from human contact. Water from the reservoir is piped downstream to the Cayucos Water Treatment Plant (WTP) where it is treated by a filtration system followed by chlorination. Prior to chlorination, a percentage of the water is passed through two granular activated carbon filters. In addition, Cayucos has a groundwater well, the Whale Rock Well (CAWO Well).

The San Luis Obispo County Board of Supervisors meets every Tuesday (except the 5th Tuesday in a month) at 8:30am in the board chambers located in the new Government Center, 1055 Monterey Street, San Luis Obispo. Water Conservation Tips for Consumers

Did you know that the average U.S. household uses approximately 400 gallons of water per day or 100 gallons per person per day? Luckily, there are many low-cost and no-cost ways to conserve water. Small changes can make a big difference – try one today and soon it will become second nature.

- Take short showers – a 5 minutes shower uses 4 to 5 gallons of water compared to up to 50 gallons for a bath.
- Shut off water while brushing your teeth, washing your hair, or shaving, and save up to 500 gallons a month.
- Use a water-efficient showerhead. They are inexpensive, easy to install, and can save you up to 750 gallons a month.
- Run your clothes washer and dishwasher only when they are full. You can save up to 1,000 gallons a month.
- Water plants only when necessary.
- Fix leaking toilets and faucets. Faucet washers are inexpensive and take only a few minutes to replace. To check your toilet for a leak, place a few drops of food coloring in the tank and wait. If it seeps into the toilet bowl without flushing, you have a leak. Fixing it or replacing it with a new, more efficient model can save up to 1,000 gallons a month.
