1	Active Commercial Use Permit Required
2	Jet Fuel & Aviation Gasoline rates subject to change per market conditions
3	Application fee is non-refundable and due with application submittal. Additional fees may apply for impacts, excess County staff hours, encroachment permits, FAA review, or extended term of permit on a case basis.
4	Restrictions apply. Camping is limited to pilots approved to fly into airport.
5	Badge Renewal Fee is charged upon badge expiration and renewal. Renewal frequency varies depending on badge type. Frequency is annual or biennial (once every two years), depending on badge type. Any badge expired more than 30 days is dropped out of the security system by the Transportation Security Administration, and the customer will be subject to the first time badge fee.
6	Periodic Increase may apply be applied based on current market appraisal.
7	Annual Parking Permit is issued for a 12 month period, and not per calendar year. Permit is not prorated and available for use in Lots 1 & 2 only. Subject to availability at the discretion of the Airport Director
8	Commercial Tenant Monthly Parking Pass is subject to availability at the discretion of the Airport Director
9	Airport parking at a \$20/day max charge, as determined by the Director of Airports on an as-needed basis, to allow real-time parking capacity/demand management.
