 - i. Status of identified projects on the 2015/16 Bikeways Plan Jake discusses the Class 1 and 2 bike way priorities.

A-town to Templeton connector update: Underway but not completely funded, programmed cycle 8 ATP grant funding.

Darren – there was a grant due to expire – did that get resolved?

Skip – Is there still a right of way issue? Is on hold / living with County Parks

Jake – Bob Jones Trail Overview (A ii): a Property owner is not willing to sell, and board cannot claim imminent domain so we are looking at two different options for the path. Will stop at the property line until there is a future determination.

Skip – Question about alignment of the trail for both options

Jake – explains both trail layouts.

Lea – a determination from the Active Transportation Committee is required in regards to if either option is feasible under the 18 million dollar grant that has already been awarded.

Officer Molinar – reports on bike related collisions in SLO CHP patrol area from X to X. 3 collisions where bikes were at fault. Collsions seem to be at all hours of the day. Kimberley – askes about a collision that occurred on Tefft

Jim – clarifies the reason he inquires about when the cyclist is actually at fault. Often, when the cyclist is at fault it is actually due to a design fault

Officer Molinar – No calls on Ebikes

Molinar – Unfortunately we cannot control what someone pays for as a service. Someone can take the ticket to the business to remove the tint and they must remove.

Skip – I've proposed to mimick the American River Parkway (walk on to oncoming traffic)

Andy – hopefully some funding can come from SLOCOG

Lea – municipalities have authority to setting some speed limits for EBikes (presents example on Bob Jones) The problem is no enforcement. I suggest talking to Shaun about posting

Josh – one more facilityes question in honor of Red Davis – Boulard reflectors are dim in Los Osos, I would suggest to design something other than boulards to keep cars out of multipurpose paths.

Skip – Speaks to example / inovaltive engineering, Skip I would like to present on a Boulard presentation (have Jake discuss)

Lea – Does the County have a Boulard policy / County standard? Why are they painted brown?? Skip – Aren't they supposed to be reflective? It's illegal
