This election offers a myriad of changes for our voters both due to legislative actions and county processes.

# CHANGES TO THE CALIFORNIA PRIMARY SYSTEM

**TOP-TWO OPEN PRIMARY ACT:** On June 8, 2010, California voters approved Proposition 14, which created the "Top Two Open Primary Act". This means candidates, regardless of their party preference, will appear on a single combined ballot and voters can vote for any candidate from any political party. This Act does not affect the election of President, which is still party specific.

The "Top-Two Open Primary Act" changes the way elections are conducted for all statewide (i.e. Governor, etc) and legislative offices (U.S. Senate, U.S. Representative, State Senate and State Assembly. These contests are now known as voter-nominated. In these contests, the two candidates who receive the highest and second-highest number of votes cast in the Primary Election will appear on the ballot at the General Election. The rules for Non-Partisan (State Superintendent of Schools, Judicial, County and other local jurisdictions) offices will remain the same.

# NO PARTY PREFERENCE (NPP) (FORMERLY DECLINE TO STATE):

This is the new designation for Decline to State or Non-Partisan Voters, along with all voters registered with unqualified political parties.

**CANDIDATES STATE THEIR PARTY PREFERENCE:** The primary contest for voter nominated offices is no longer conducted to select the party's nominee for an office, instead these candidates are nominated by the voters. All candidates are required to state their party preference as indicated on their voter registration and this preference is printed on the ballot to the right of the candidate's name. If a candidate did not state a party preference on their voter registration it will be listed as Party Preference: None. The party preference of the candidate does not imply an endorsement of the party listed, however the parties are allowed to provide their endorsements and have those endorsements printed in the county sample ballot booklet at no charge to the party- see page 30 for this listing.

**PARTY REGISTRATION STILL MATTERS:** Because the Presidential nominee contest continues to be a partisan office, only those voters who are registered with a specific party can vote that party's ballot (with the exception of Cross-over voters-see below). Voters registered with a qualified political party are not eligible to cross over to any other party's ballot.

**CROSSOVER VOTING**: Due to the Presidential primary contest, the ballots for the 2012 Primary Election will be comprised of 6 different party ballots and a Non-Partisan ballot. Voters who are listed as NPP have the option to participate in the election with the Non-Partisan ballot (no Presidential Contest) or cross over and request a party ballot from the parties allowing those voters to participate. The parties allowing NPP participation are the American Independent Party and the Democratic Party.

# **REDISTRICTING- NEW DISTRICT LINES**

Every 10 years, following the US Census, all district lines are changed to equalize the population represented by each district. This process was completed in 2011 both at the state and local level. The major change for San Luis Obispo County is that all voters are now represented by one congressional representative. In addition the district boundary lines and numbers have changed for Congressional, Senate, and Assembly. San Luis Obispo is now represented by Congressional District 24, Assembly Districts 35 and 37 (the portion of the county in the 37th is very small and uninhabited) and Senate District 17. The Supervisorial Lines have been redrawn throughout the County as well. These changes will affect voters who were near the border of the old lines, for instance eastern Templeton and Creston and voters in the City of San Luis Obispo and Edna Valley may now be in a different district than before. Voters can use our voter registration status lookup to determine which district represent the area in which they live- see page 5.

### **NEW POLITICAL PARTY**

Americans Elect is a new political party that has qualified in the state of California. The party is not participating in the June 5, 2012 Presidential Primary and any voters registered with Americans Elect will be issued a Non-Partisan ballot. The 7 qualified political parties are: American Independent, Americans Elect, Democratic, Green, Libertarian, Peace and Freedom and Republican.

# SAMPLE BALLOT OPT OUT

New legislation allows voters to "Opt Out" of receiving a sample ballot, voter pamphlet (information guide), notice of polling place, and associated materials by mail, and instead obtain them electronically on the County's Website. For every voter that "opts out", the county will save between 50 and 70 cents on printing and mailing costs. About 6 weeks prior to Election Day, the Clerk-Recorder will directly email voters, as well as post announcements on the Clerk-Recorder's Twitter and Facebook accounts, that this information is available online and the voter can access the information at their convenience.

# CHANGES TO REDUCE COUNTY COSTS

**Digest Sized Books-** Due to recent changes which increased postage to send full-sized booklets, the sample ballot booklet was reformatted to a "digest-sized" booklet ( $5.5 \times 8.5$ ). By reformatting this booklet, the county will be sending the voter information guide at the most efficient postage rates. Because of this change in the size of the booklet, the contests on the ballot are laid out over a series of pages. The contests are in the same order as on the ballot but the voter does not have an exact replica of the 14 inch ballot used for this election.

**Sample Ballot Booklet only sent to Non Permanent Vote By Mail Voters-** The County Sample Ballot Booklet and Voter Information Guide is required to be sent to all voters and is typically mailed on E-40 (April 26). To help save costs associated with the additional mailing, this booklet and the vote-by-mail ballot are included in one envelope for the nearly 80,000 voters who are registered as Permanent Vote-by-mail voters or who reside in a Mail Ballot Precinct. The all inclusive mailing to these voters will take place on May 7.

# NEW POLLING PLACES- VOTERS NEED TO CHECK POLLING PLACE LOCATION BEFORE HEADING OUT ON ELECTION DAY- In San Luis Obispo

County, we rely on public buildings for polling places. Using these buildings gives more stability to the polling place locations and does not leave the voters and precinct workers susceptible to poor weather and changes to locations because of vacations or illnesses. However the demand for these buildings is great and although our local agencies, schools and churches are also cooperative in ensuring we have sufficient space for election day activities, some polling places may change from previous locations due to scheduling conflicts. For instance, we will not be using the Mid State Fairgrounds as a polling place in the 2012 elections. In past elections over 5000 voters have been assigned to this site alone. As always, it is important that voters check to make sure they know the polling place to which they are assigned, either by looking on their sample ballot or using our on-line polling place search- see page 6.

# WEBSITE CHANGES AND NEW FEATURES

**NEW URL-** The election information can now be accessed using **www.slovote.com**. This will link directly to the election page of the County Clerk-Recorder website.

### **ON-LINE FORM FOR VOTER REGISTRATION**

Voters can now complete a voter registration form on-line. Once the forms is completed, the voter will print the form, sign it and mail it to the Elections Office. This will be especially helpful for voters when the voter registration deadline is near.

Please provide either a California driver's license or California ID card number or the last 4 digits of your Social Security Number. To access the information, the voter is required to enter their birthdate, last 4 digits of their CA driver's license and the numbers of their street address. If an exact match is found, their registration status will be confirmed, their vote-by-mail ballot status information for the current election and the districts in which they reside will be displayed. To maintain voter confidentiality, the system will not display the voter's name or address but will merely confirm their registration status. The system will be updated daily with both registration and vote-by-mail status information. If the voter is unable to find the information on the web, they can continue to contact our office by phone at 781-5228 or by email at <u>elections@co.slo.ca.us</u>.

# POLITICAL PARTY CENTRAL COMMITTEES AND COUNTY COMMITTEES INSUFFICIENT NOMINEES

All political party central committees and county councils are elected at the primary election. These offices remain a partisan office and are open only to candidates and voters registered with the specific party. The following seats were open for each of the political parties: Democratic- 23 members, Republican- 22 members, American Independent- 25 members- these three parties elect their central committees by supervisorial district and Green and Peace & Freedom – 7 members- elected at large throughout the county.

During the nomination period, 27 candidates qualified for these 84 positions. Since there were nominees equal to or less than the number of positions in each contest, none of these contests will be on the ballot. The candidates who filed the appropriate papers will be declared appointed in lieu of election by the Board of Supervisors.

# PLACEMENT ON THE BALLOT/ROTATION OF CANDIDATES

The order in which candidates' names appear on the ballot is determined by a random drawing of the 26 letters of the alphabet. This random drawing is conducted by the Secretary of State and the County Clerk-Recorder prior to each election. The random drawing for this election was held on March 15, 2012.

Election law also requires the names of candidates for some offices to change positions, such as federal, statewide and county wide offices (i.e. Governor, United States Senator, Secretary of State, United States Representative). The purpose of the rotation is so one candidate's name does not always appear first, or last, on <u>all</u> of the ballots for the races.

As required by state law, names of candidates for certain offices are rotated on the ballot as follows:

OFFICE	ROTATION
Statewide Offices, United States Representative, Board of Equalization member	Candidates' names are arranged in accordance with the alphabetical drawing beginning with the lowest numbered Assembly District in the State or Congressional or Board of Equalization District. Thereafter, for each succeeding Assembly District, the candidate's name appearing first is placed last; the order of the other names remains unchanged. Since San Luis Obispo County is represented by only one Assembly District, these candidates will be in the same order on every ballot in this county.
State Senate and State Assembly	For multi-county districts, such as the senate and assembly each county conducts a random drawing and the candidates' names are arranged in accordance with each county's alphabetical drawing- no other rotation.

# VOTE -BY- MAIL BALLOT INFORMATION

**History:** Absentee ballots were first made available by the North for the soldiers and sailors in the Civil War. California first allowed absentee voting in 1920 for those who were ill or disabled, lived too far from the polls and other special circumstances. In 1978 legislation was passed which allowed universal absentee voting. As a result of this change allowing any person to vote absentee (now vote-by-mail), it has become a very popular means to cast a ballot. See the chart on page 8 to track the trend of voters casting their ballots by mail. In 2002, permanent absentee voting was expanded to any voter upon request. There are currently over 76,500 permanent vote-by-mail voters in San Luis Obispo County totaling more than 52.5% of the total registered voters.

# How To Apply for a Vote-by-Mail Ballot:

The first day this office can issue a vote-by-mail ballot for the Primary Election is May 7, 2012 (29 days before the election). Vote-by-mail ballot requests must be received no later than May 29th in order for the ballot to be mailed to the voter. After that date, the voter must appear in the Office of the County Clerk-Recorder and complete an application indicating the reason they cannot appear at the polls on Election day. Vote-by-mail ballots may be requested in one of four ways:

- By filling out and mailing the Vote by Mail Application on the back cover of the sample ballot booklet. Sample ballot booklets will be mailed April 26.
- By letter to the County Clerk-Recorder, 1055 Monterey St., D120 San Luis Obispo CA 93408. The letter must state the voter's name, residence address, address to which the ballot should be sent and voter's signature.
- In person at the County Clerk-Recorder's Office- in San Luis Obispo at the address above or for voters living in the North County, at our office in Atascadero- 5955 Capistrano Ave., Suite B. The office hours in Atascadero are 7:30-4:00.
- By faxing a written request to the County Clerk-Recorder's Office at 781-1111.

Vote-by-mail ballots cannot be requested over the telephone as a written request from the voter is required.

To be counted, the voted ballot must be mailed in time to be received by the County Clerk-Recorder's office by 8:00 p.m. on June 5, 2012 or returned by the voter personally to any polling place in the county no later than 8:00 p.m. on Election Day. Due to proposed changes in delivery of U.S. mail, it is recommended that voters do not mail ballots after the Wednesday prior to the election to ensure that the ballot will be received in time to be counted. The voter may also authorize a designated family member to return the voted ballot to any polling place in the county or to the County Clerk-Recorder's Office.

# WEEKEND VOTING

The County Clerk-Recorder's Office will be open on the Saturday before the election from 9:00 a.m. to 1:00 p.m. to issue vote-by-mail ballots. Voters may vote the ballot in the office at the voting booths or have a family member return the ballot for them by 8:00 p.m. on Election Day.

### PREPARING FOR THE ELECTION THE READER'S DIGEST VERSION E-120 TO ELECTION DAY

The staff of the County Clerk-Recorder's Office begins preparation for a county wide election at least six months prior to Election Day and after that every day is counted as E-the number of days left. You could ask any employee in our office (and probably any candidate) how many days until the election and we won't even have to think twice to answer. Some of the important dates and the activities surrounding them are:

E minus number	Date	Activity
E-158	December 31, 2011	First day to issue signature in lieu of filing fees petitions to candidates to help defray their filings fees.
E-E-127	January 30	Letters sent to polling places
E-113	February 13	Opening of the nomination period.
E- 110	February 16	Initial letters sent to potential precinct workers for commitments to work on election day.
E-88	March 9	Close of the nomination period. After the close of nomination, the ballot layout and preparation begins. Proofing of the sample ballots and ballot information continues through early April. The vote-by-mail ballots are received by the end of April and the sample ballot mailing is completed around the same time.
E-70	March 27	Assignment letters to precinct workers that have been assigned to polling places.
E-60	April 6	60 day close. This is the initial target date for ensuring that the voter rolls are as updated as possible. Any voter registration in our office by that date is processed into the system and all changes and deletes are accomplished before officially closing our files. The 60 day close file is sent to the Secretary of State and the printer who prepares and mails San Luis Obispo County sample ballots. These names constitute the first mailing of state ballot pamphlets and sample ballot pamphlets. Any changes or anyone who registers between this date and the 29 day close of registration (May 7) will be mailed the voter information in the second mailing, scheduled for mailing the week of May 21.
E- 56 to E-14	April 9 – May 22	Write-in candidate nomination period.
E-40	April 26	Sample Ballot booklets are mailed to voters who have not signed up to be a permanent vote-by-mail voter or do not live in a mail ballot precinct.
E-43 to E-20	April 23-May 14	Testing of voting machines and ballot counting software. Certification to transmit election night results to the Secretary of State.

E-29	May 7	The "informed voter" close of registration as well as the first day to issue vote-by-mail ballots. Vote-by-mail ballots are mailed to the 76,500 voters who are signed up a permanent VBM voters and to those who live in mail ballot precincts. During the week of the close of registration, staff is busy processing voter registrations. These must be completed by the end of the week so new voters can be sent their sample ballot booklets and state voter information guides in a timely manner. While this is going on the voting booths and precinct supplies are being prepared for delivery to the county's 135 precincts and last minute changes
		to precinct worker assignments are made. During the month of May, staff is conducting 15 training sessions for the 700+ volunteers working at the polls.
E-15	May 21	Official close of registration. Anyone registered between May 8 and May 21 is eligible to vote however, the voter will not receive the state voter information guide or the county sample ballot booklet. The voter will receive a postcard indicating their polling place location and where they can obtain voter information.
E-11	May 24	Elections staff begins opening and preparing the vote-by-mail ballots for counting.
E-10	May 25	Elections staff begins counting the vote-by-mail ballots. No results are released until after the close of polls on Election Night.
E-7	May 29	Copy of ballot counting software is deposited with the Secretary of State.
E-7	May 29	Last day to mail vote-by-mail ballots to voters. After this day, a voter must appear in the office to receive a ballot. The final week before the election precinct supplies are distributed to the precinct inspectors.
E-6 to E Day	May 30 – June 5	Vote-by-mail ballots can be requested in person at the Clerk-Recorder's Office.
E-2	June 3	Delivery crew picks up voting booths, ballot box and other equipment for delivery to polls
E-1	June 4	Delivery crews delivers and sets up voting equipment at 75 polling places throughout the county.
E Day	June 5	Polls are open from 7:00 am to 8:00 pm Election day begins at 6:00 a.m. and should end around 1:00 am for the County Clerk- Recorder staff, although final election night results should be completed by 12:30 am
E+1	June 6	Delivery crew picks up and returns all voting equipment to the Elections warehouse. Election staff records number of outstanding

E+2	June 7	Official Canvass begins – see process outline below.						
E+28	July 3	Official canvass completion and election certification deadline.						

# **ELECTION NIGHT PROCEDURES**

After the last voter in line at 8:00 has cast their ballot, the precinct workers pack up and return precinct materials and the voted ballots in sealed containers to either the regional collection centers or directly to the Elections office in San Luis Obispo. Elections staff verifies that all ballots and required materials have been received and that security measures have been followed prior to releasing the precinct workers. All ballots and materials are brought to the Government Center in San Luis Obispo for ballot counting and secure storage.

# SPEED OF BALLOT COUNTING ELECTION NIGHT

As in the past, results of early vote-by-mail ballots (those received by Saturday, June 2nd) will be available immediately after 8:00 pm. The ballots will be counted centrally in the County Clerk-Recorder's office on Election Night instead of at the polls during the day. The ballots will be transported from our regional collection centers in Paso Robles, Atascadero, Morro Bay and Arroyo Grande to the Government Center and fed through the Accuvote scanners by county staff. Final election night results should be available by 12:00 a.m.

# INCOMPLETE BALLOT COUNTING ELECTION NIGHT

The public is often surprised on the day after a major election when they learn that there are as many as 15,000 ballots county wide remaining to be counted after the election. There are three categories of ballots which cannot be processed on Election Night:

- VOTE-BY-MAIL BALLOTS TURNED IN ELECTION DAY- Many vote-by-mail voters wait until Election Day to make their voting choices and then drop off their ballots at a polling place. These ballots are received after the polls close on election night. All vote-by-mail ballots must be pre-processed before they are counted- including entering that the ballot has been returned to protect against double voting and verifying the voter's signature on every envelope against the signature on file in our office.
- 2. PROVISIONAL BALLOTS- Provisional Ballots are voted at the polls when the precinct workers cannot determine the voter's eligibility to vote in that election. Provisional ballots are sealed in special envelopes and must be individually researched and verified at the County Clerk-Recorder's Office before the ballots is counted or rejected in accordance with election laws. There are several reasons why someone would be required to vote a provisional ballot at the polling location:
  - □ Voter is listed as having received a vote-by-mail ballot but does not have the ballot to surrender at the polls.
  - □ Voter is voting under the fail safe provisions of the National Voting Rights Act. A fail safe voter is a registered voter in this county, who has moved and

did not re-register to vote or notify the elections office of his/her change of address.

- □ Voter insists on voting a ballot for a party other than the party indicated in the roster.
- □ Voter's name is not on the roster, but the voter insists they are eligible to vote in that precinct.
- □ Voter is required to show identification as a first time voter under the Help America Vote Act and cannot produce the required identification.

In each of these instances, the elections staff must verify that the voter is eligible to vote the ballot they were issued and verify the voter's signature prior to opening the ballot for processing. The number of provisional ballots continues to climb and in the November 2008 election there were 3,716 provisional ballots requiring about 400 hours of staff time to verify, open and count.

3. DAMAGED BALLOTS: Election Day ballots that are unable to be processed by the ballot scanners because of stray marks, overvotes or tears and need to be duplicated prior to counting.

The majority of the vote-by-mail ballots are counted by the Friday after the election. Some of these ballots require additional processing and their count is completed in the week following the election. The provisional and damaged ballots are normally counted just prior to certification of the results. Results are released as a count is completed and a schedule of counting dates and times will be posted on the County Clerk-Recorder website after the election.

# WRAPPING UP THE ELECTION WHAT IS THE OFFICIAL CANVASS?

The election canvass process is an internal audit required by state law to ensure the accuracy of election results. California election law allows 28 days to conduct the official canvass of final election results. The official canvass begins on Thursday, June 7 and must be concluded within 28 days, no later than July 3. San Luis Obispo County normally completes the official canvass within 17 days of the election. All aspects of the canvass are open to the public. The canvass concludes with the certification and issuance of official election results. Listed below are the major components of the official canvass.

# Completion of the count for vote-by-mail and provisional ballots- as described above.

**Election Materials accounted for-** Staff verifies that all elections materials have been returned and accounted for and that precinct workers have correctly followed Election Day procedures.

**Roster Reconciliation-** Following the close of the polls on Election Day, precinct officers are responsible for completing the Official Ballot Statement shown below.

As part of the official canvass, the signatures in each roster are re-counted and the number of signatures indicated by the inspector on the roster is compared to the number of ballots tabulated by the computer tally system. Any discrepancies are investigated. The balancing process normally takes 10 days to complete.

**Manual Vote Tally-** All voted ballots from at least 2 precincts (1% of the 132 precincts) are manually tallied for every contests and balanced against the computer counts to verify the accuracy of the election tally system. For any contest which is not on the ballot in one of those two precincts, an additional precinct's ballots are counted for that contest only. In addition, this same procedure is completed for 1% of the vote-by-mail ballots. The completion of the manual tally usually takes 2-4 days, depending on the number of contests on the ballot and the voter turnout.

Apply Voting History- All voters who voted at the polls are given credit for voting.

**Account for all ballots-** The number of precinct and vote-by-mail ballots printed, issued and unused are accounted for and balanced. Discrepancies are investigated.

**Certify Election and report to the Secretary of State -** Registrar of Voters certifies the Election and sends the certification, statement of vote and supplemental statement of vote to the Secretary of State. Board item is prepared to present to the Board of Supervisors.

There are some interesting trends:

- Overall, voter registration has increased by 1,675 voters or 1.1%.
- ◊The number voters who have selected the Democratic Party has decreased by 535 or 1%
- ♦ The number voters who have selected the Republican Party has decreased by 2,135 or 3.5%
- ◊The number of voters who have chosen to not state a party preference or are registered with a party that is not qualified for the ballot in California has increased by 4,484 or 17%.

# WHAT'S NEW FOR THIS ELECTION

# **Top Two Primary**

# What is it?

In 2010, California voters approved Proposition 14 creating the "Top-Two Primary," which replaced the traditional party-nominated primary. Under the Top-Two Primary laws, all candidates running, regardless of their party preference, appear on a single combined ballot, and voters can vote for any candidate from any political party. The candidates who receive the highest and second-highest number of votes cast at the Primary election advance to the General election. This change applies to federal and state contests, except for President. The rules for non-partisan contests (i.e. counties, cities, school and special districts) did not change.

# For the Presidential Primary, Party Ballots Still Exist

Since the Top Two Primary rules do not affect the election of party nominee for President, party-specific ballots will be issued for this Presidential Primary Election. Only voters who are registered to vote with a specific party are allowed to vote in that party's Presidential nominee contest. The only exception to this is voters who have not selected a party preference may be allowed to vote in a party's Presidential election, if the party authorizes this- see information on choosing a party ballot.

# All Other Contests Are Open to All Voters

The new rules apply to U.S. Senate, U.S. Congressional, statewide and state legislative offices. Candidates for these offices are no longer nominated by party. As a result, voters can vote for any candidate on the ballot regardless of the candidate's party preference. These contests are now referred to as "voter-nominated offices." Again, in these contests, only the two candidates who receive the highest and second-highest vote totals will be on the ballot in the November General Election.

# Party Preference and Political Party Endorsement

The term "party preference" is now used in place of the term "party affiliation". Similarly, voters who were previously known as "decline-to-state" voters (because they did not have a party affiliation) are now known as "no party preference" or "NPP" voters.

On the ballot, the political party preference, or no party preference, as indicated on the candidate's voter registration will be listed next to or SBVBM-NPNW-1 SL 000-000

below the candidate's name. The party designation is shown on the ballot for the information of the voters only and it does not constitute or imply an endorsement by the party designated. Parties may provide a list of candidates who have received the official endorsement of the party for printing in this booklet.

# Write-In Candidates

Write-in candidates are eligible to run in the Primary, and voters can cast their vote for that candidate by writing in the candidate's name and filling in the oval next to the write-in line. If a qualified write-in candidate is one of the top two candidates, under the new rule, that candidate will advance to and have their name printed on the General election ballot.

# **Changes due to Redistricting**

After the 2010 decennial census, all legislative district lines for federal, state and county offices were redrawn. These lines have been put into place and the candidates on the ballot which you are issued are determined by the district in which you reside. Voters in San Luis Obispo County remain in one state senate district (the 17<sup>th</sup>) and one assembly district (the 35<sup>th</sup>). The county is once again represented by one congressional district (the 24<sup>th</sup>). In addition, the lines designating the 5 districts represented by the Board of Supervisors were redrawn and your residence may now be located in a different district than before. ## TAX RATE STATEMENT MEASURE A-12

An election will be held in the City of Arroyo Grande (the "City") on June 5, 2012, to authorize the sale of up to \$6,700,000 in bonds of the City to finance construction of a new Police Station and refinance the 2003 Fire Station bonds as described in the proposition. If the bonds are approved, the City expects to sell the bonds in single series in fiscal year 2012-2013. Principal of and interest on the bonds will be payable in part from the proceeds of tax levies made upon the taxable property in the City. The following information is provided in compliance with Sections 9400-9405 of the Elections Code of the State of California.

- 1. The best estimate of the tax which would be required to be levied to fund this bond issue during the first fiscal year after the sale of the bonds, based on estimated assessed valuations available at the time of filing of this statement, is .00817 cents per \$100 assessed valuation (\$8.17 per \$100,000) of assessed valuation in fiscal year 2012-13.
- 2. The best estimate of the highest tax rate which would be required to be levied to fund this bond issue, based on estimated assessed valuations available at the time of filing of this statement, is .00817 cents per \$100 assessed valuation (\$8.17 per \$100,000) of assessed valuation in fiscal year 2012-13.

Voters should note that it is the intention of the City to pay a portion of annual bond payments with revenues from the 2006 Local Sales Tax Measure so as to maintain the tax rate at or below the existing tax rate for the Fire Station Bonds, which is currently .00817 cents per \$100 assessed valuation.

Voters should note that the estimated tax rates are based on the *assessed* value of taxable property on the official tax roles of the city, <u>not</u> on the property's market value. In addition, taxpayers eligible for a property tax exemption, such as the homeowner's exemption, will be taxed at a lower effective tax rate than described above. Property owners should consult their own property tax bills and tax advisors to determine their property's assessed value and any applicable tax exemptions.

Attention of all voters is directed to the fact that the foregoing information is based on the City's current projections and estimates only. The actual tax rates and the years in which they will apply may vary from those presently estimated, due to variations from these estimates in the timing of the bond sale, the amount of bonds sold, interest rates at the time of bond sale, and actual assessed valuations over the term of repayment of the bonds. The date of sale and the amount of bonds sold will be determined by the City based on need for construction funds and other factors. The actual interest rate at which the bonds will be sold, not to exceed 6.5% per annum, will depend on the bond market at the time of sale. Actual future assessed valuations will depend upon the amount of taxable property within the City as determined by the County Assessor in the annual assessment and the equalization process.

#### IMPARTIAL ANALYSIS MEASURE A-12

Measure A-12 was unanimously placed on the ballot by the Arroyo Grande City Council to ask voters to authorize the issuance and sale of general obligation bonds in an amount up to \$6,700,000 to construct a new Police Station. California law authorizes cities to issue general obligation bonds to finance "municipal improvements", including the construction of police stations. The proposed new 30 year bonds include an amount sufficient to retire the bonds that were issued in 2003 to construct the Fire Station.

The proposed funding includes repaying the bonds partly through a real property tax at a tax assessment rate equal to or below the existing tax rate for the Fire Station bonds, and also using funds from the 2006 Local Sales Tax Measure to pay the balance of the bond payment. Funding is also based upon purchase of the bonds by the U.S. Department of Agriculture through a low-interest community facility financing program, for which an application has been submitted by the City.

The real property tax would be assessed on the value of commercial, residential, industrial, agricultural and utility property within the City. According to the tax rate statement provided by the City's financial consultant, the best estimate of the highest annual tax rate to property owners is \$8.17 for each \$100,000 of assessed value, which is the same as the current tax rate for the Fire Station bonds.

The existing Police Station was acquired in 1973 and was last expanded in 1989. Since 1973, staffing has grown from 12 full-time and 6 part-time employees to 34 full-time and 15 part-time employees in 2012. The proposed new Police Station will meet the following needs that have been identified by City staff: an emergency operations center, the 9-1-1 system, expansion of the dispatch center, expansion of evidence and equipment storage and additional parking for police vehicles and staff. The proposed new Police Station is planned to be built on City owned property at the corner of West Branch Street and Old Ranch Road.

A "yes" vote is a vote in favor of authorizing the City of Arroyo Grande to issue and sell general obligation bonds not to exceed the principal amount of \$6,700,000, to retire the 2003 Fire Station bonds and construct a new Police Station.

A "no" vote is a vote to not authorize the issuance and sale of said bonds.

The Measure will pass if two-thirds of those voting on the measure vote "yes".

# ARGUMENT IN FAVOR OF MEASURE A-12

Keeping people in the community safe is the most important function the City provides. To do this effectively requires not only dedicated personnel, but also adequate equipment and facilities. Your "YES" vote on Measure A-12 will provide funding to construct a much needed new Police Station on City-owned property at West Branch Street and Old Ranch Road.

The Police Department has grown to meet the community's needs since the existing building began housing the City's police force in 1973. As a result, space in the existing building is inadequate to enable performance of necessary functions. Additional space is vitally needed for an emergency operations center, evidence and computer storage, the 9-1-1 system, expansion of the dispatch center, detective offices, and employee parking.

An independent study of multiple alternatives has determined the most cost effective site and design to meet these needs. Waiting would only increase costs and reduce the availability of Federal financing assistance.

The City is acutely aware of the impacts the economy has had on its residents. Therefore, the proposed financing has been structured to fund the project <u>without</u> raising your annual tax rates.

Approval of this measure will authorize the sale of bonds to fund the major portion of the project costs. The bonds will be repaid without raising property tax rates by refinancing bonds issued in 2003 to expand the Fire Station. The balance of debt costs will be paid from local sales tax funds programmed for a new Police Station.

Arroyo Grande citizens depend on the Police Department for protection and a safe community. Now Officers are depending on you to provide them with the facilities needed to do their job. Your City Council strongly urges you to vote "YES" on Measure A-12.
