COVID-19 Status in SLO County as of 12/8/21

Dr. Borenstein reported that the County has been experiencing a stagnation, if not increase, of new COVID-19 cases. 1,754 people were diagnosed with COVID-19 since the October 27th report. SLO County has seen a very slight decrease in the number of hospitalizations in the past month and a half. Currently, 11 people are hospitalized, 3 of which are in the ICU. 26 additional COVID-19 deaths have been reported since October 27th. To date, 365 people have died due to COVID-19 and at least 3 deaths are pending final certification.

Community Transmission – SLO County

The following 7-day metrics are from the week of November 29th – December 6th. San Luis Obispo County has moved back to the High (Red) Tier based on the CDC's community transmission metrics. The current COVID-19 case rate among SLO County residents is 131.75 per 100,000. Please view the <u>CDC COVID-19 Data Tracker</u> for more information.

SLO County Outbreak Data

Youth and congregate settings continue to be impacted by COVID-19 viral outbreaks within SLO County. Outbreaks remain most prevalent in K-12 locations, with 37 schools with active cases as of December 8th. Currently, there are 10 outbreaks in preschool/childcare locations and 10 outbreaks in congregate settings.

SLO County Vaccine Status of COVID-19 Cases

Unvaccinated individuals are disproportionately impacted by COVID-19. Since June 15, 2021, SLO County residents who are not fully vaccinated encompass at least 76.8% of COVID-19 cases, 82.4% of hospitalizations, and 73.3% deaths.

Unvaccinated individuals are 6-8x more likely to be infected by COVID-19, 12-15x more likely to be hospitalized, and 15-20x more likely to die than fully vaccinated individuals.

Vaccination Rates by Age in SLO County

The percentages below indicate the percent of fully vaccinated residents as of 12/6/21. Please note booster doses have not been incorporated into this data metric.

75+:77%65-74:79%50-64:76%40-49:73%30-39:71%18-29:50%12-17:51%5-11:6%

Approximately 1 in 4 (23%) of SLO county residents who are ages 75 and older remain unvaccinated. This statistic is concerning, as individuals within this age group are disproportionately impacted by COVID-19 illness and related complications.

SLO County residents with at least one dose = 70.5% compared to CA at 76.9%. The County's full vaccination rate has noticeably decreased since October 27th report, with a previous rate of 72.6%. Since vaccine eligibility expanded to include children ages 5-11, this rate now encompasses a larger vaccine eligible population. The statistical difference remains between SLO County and California's full vaccination rates.

Boosters/Additional Doses, by Age in SLO County

The findings below indicate the number of booster/additional doses given to residents as of 12/5/21.

65+:31,91950-64:13,14718-49:11,24812-17:45

In comparison to the County's vaccination progress trends, a significant percentage of SLO County residents have not received a booster/additional dose. County of San Luis Obispo Public Health Department recommends that everyone ages 18 and older *should* get a booster dose to prevent widespread COVID-19 transmission. Booster doses may be instrumental in preventing a winter surge and the newly identified Omicron variant.

Omicron

On November 24th, 2021, a new variant of SARS-Cov-2 was reported by the World Health Organization. This new variant, known as Omicron, has now been classified as a variant of concern. Currently, it is unknown whether the Omicron variant causes more severe illness than other variants or how it might impact response to treatment. Please view the <u>CDC Omicron Variant</u> webpage for more information. Variants have many mutations which impacts infectiousness and the ability for immune systems to protect against infection. New variants will continue to evolve while there are large proportions of unvaccinated individuals.

Boosters

All three Pfizer, Moderna, and Johnson & Johnson booster doses have been reviewed, approved, and recommended by the FDA, CDC, the Western States Scientific Safety Review Workgroup, and California Department of Public Health. See below for <u>booster dose eligibility</u>.

<u> Moderna + Pfizer:</u>

• Eligible 6 months or more after receiving their 2-dose series:

<u>]&] vaccine (age 18+):</u>

• Eligible 2 months or more after receiving the initial dose

All COVID-19 vaccine boosters result in robust protection from COVID-19 infection. Boosters are strongly recommended for individuals who are 50 yrs. and older, residents of long-term care facilities, those with underlying medical conditions, those with increased risk of social inequities, and those residing or working in high-risk exposure settings.

Booster and Pediatric Demand

Public Health static clinics are currently seeing an uptake of vaccine appointments for the month of December. Appointment scheduling challenges have been identified, particularly among the older age group and those with access issues. Providers are encouraged to increase booster and pediatric vaccine appointment availability to meet capacity demands.

Healthcare Provider Updates

<u>CHC</u> – Jose Guzman indicated that all 3 vaccine brands are available at CHC clinic locations. Patients can call (805) 361-8400 to schedule testing and vaccine appointments. *Day of the Farmworker* event was reportedly successful, with over 400 attendees and 200 vaccine doses given.

CHC has also begun promoting pediatric doses among clinic locations and community events.

<u>CenCal Health</u> - Primary strategy is increasing amount of healthcare providers who will administer vaccine. Strategies include outreach partnership and incentives for vaccine administrators. Vaccine recipients will receive a \$50 incentive for first dose received. CenCal is actively promoting mobile vaccination clinics for SLO County.

- Provider Incentive
 - o Available to PCPs FQHC's and non-FQHCs
 - o PCP will receive \$50.00 per member who receives their first dose of the COVID-19 vaccine. The max a provider can earn per member is \$50.00.
 - o Limited to vaccines rendered between October 2021 and March 2022.

<u>Long term care and hospital facilities</u> – Reported fewer viral outbreaks occurring within these facilities, attributes these trends to high vaccine uptake among patients and residential staff. High vaccination rates among staff are likely due to the <u>healthcare provider vaccine mandate</u>, which went into effect September 30th, 2021. Based on federal changes, facilities are returning to normal visitation hours. Visits will no longer be restricted to 30 minutes and visitors can now access facilities 24/7. Some COVID-19 guidelines still apply, such as testing and PPE requirements.

<u>Public Health and Private Medical Offices:</u> Medical providers have increased administration of pediatric and adult vaccine doses within SLO County. Providers who administer flu or other vaccines are encouraged to offer the COVID-19 vaccine to patients.

COVID-19 vaccines will be available at each clinic, with several locations providing both COVID-19 and Flu vaccines. Promotion of these events would be greatly appreciated.

Partnerships

NAACP and County of SLO Public Health Department hosted a mobile clinic event this past November 21st at the Paso Robles Downtown City Park. Several strategies were implemented in anticipation of this event. Event information was disseminated within NAACP networks, specifically among several African American churches based in Northern SLO County. Mass communication outlets were further used for event promotion, including news releases and social media platforms. Promotional materials were distributed as well, such as t-shirts, buttons, and brochures. Canvassing and business outreach was also implemented within the surrounding neighborhoods.
