

Weekly Vaccine Shipments to SLO County Public Health*



** CDC Pharmacy Partnership for Long-Term Care Facility (LTCF) Program and Federal Retail Pharmacy Program doses are a subset of the total.



WHAT'S THE DIFFERENCE BETWEEN THE VACCINES?

All available COVID-19 vaccines have been shown to be highly effective at preventing serious impacts of the virus including hospitalizations and deaths. Their differences are primarily the dosage schedule and how they can be transported and stored, as shown below.

*All three vaccines begin to protect you soon after being administered, including with the first dose.



HEALTH AGENCY PUBLIC HEALTH DEPARTMENT

Johnson & Johnson (Janssen)

- Proven safe and effective by FDA-approved clinical trials
 - ~45,000 trial participants across 8 counties
- Administered in a single dose
 - Useful for target populations where returning for a second dose may prove difficult (unsheltered individuals, essential workers who would need to take time off work)
- Can be stored at regular refrigerator temperatures
 - Easy to transport and distribute to rural areas
- Does not contain the live virus that causes COVID-19
- Is proven to be highly effective at preventing severe illness, hospitalization, and death from COVID-19

Education & Child Care

Emergency Services

Law enforcement is working with the clinic at the jail to schedule and manage appointments for the ~200 officers still needing vaccine

Other groups within Emergency Services will follow law enforcement



HEALTH AGENCY PUBLIC HEALTH DEPARTMENT

Vaccine Prioritization (as supply allows)

- Phase 1a and Phase 1b Tier 1
- Starting March 15, Healthcare providers may vaccinate individuals age 16-64 who are at the highest risk for morbidity and mortality from COVID-19 as a result of:
 - Cancer
 - Chronic kidney disease (stage 4 and above)
 - Chronic pulmonary disease (oxygen dependent)
 - Down syndrome
 - Immunocompromised state from solid organ transplant
 - Pregnancy
 - Sickle cell disease
 - Heart conditions (excludes hypertension)
 - Severe obesity (Body Mass Index above 40kg/m2)
 - Type 2 diabetes mellitus (with hemoglobin A1c greater than 7.5%)



Vaccine Prioritization (as supply allows cont.)

OR...

If as a result of a developmental or other severe high-risk disability one or more of the following applies:

- Individual is likely to develop severe life-threatening illness or death from COVID-19 infection
- Acquiring COVID-19 will limit the individual's ability to receive ongoing care or services vital to their well-being and survival
- Providing adequate and timely COVID care will be particularly challenging due to individual's disability

Note: the list of eligible conditions is subject to change as additional scientific evidence is published and as CDPH obtains and analyzes additional state specific data.


