20 above named defendant of the following criminal offenses:

21 Count 1

22 On or about October 5, 2018, in the County of San Luis Obispo, State of California, the
23 crime of Human Trafficking Of A Minor For A Sex Act in violation of PC236.1(c)(2), a
24 Felony, was committed in that LUCION LEE EDWARD BANKS did willfully and unlawfully
25 cause, induce and/or persuade, Confidential Victim, who was less than 18 years of age, to
26 engage in a commercial sex act, with the intent to effect and/or maintain a violation of
27 Penal Code section 266, 266h, 266i, 266j, 267, 311.1, 311.4 and 311.5.

1 NOTICE: Conviction of this offense will require you to register pursuant to Penal Code
2 section 290. Willful failure to register is a crime.

3 NOTICE: Penal Code 1203.065(a) prohibits a grant of probation for this offense.
