19 The District Attorney of the San Luis Obispo County, California, hereby accuses the  
20 above named defendant of the following criminal offenses:

21 Count 1

22 On or about January 10, 2021, in the County of San Luis Obispo, State of California, the  
23 crime of First Degree Residential Burglary in violation of PC459, a Felony, was committed  
24 in that KAMMERON ISAAC ANDERSON did enter an inhabited dwelling house and trailer  
25 coach and inhabited portion of a building occupied by [REDACTED], with  
26 the intent to commit larceny and any felony.

1 NOTICE: The above offense is a serious felony within the meaning of Penal Code Section  
2 1192.7(c). It is further alleged that the above offense is a violation of Penal Code  
3 Section 462(a).

4 Enhancement

5 PC667.5(C)(21): Spec. Alleg-1st Degree Burglary/Nonparticipant Present

6 It is further alleged that as to the offense listed in Count 1, [REDACTED] [REDACTED] [REDACTED]  
7 who were not accomplices of the defendant, were present in the residence during the  
8 commission of the above offense, and that the above offense is thereby a violent felony  
9 pursuant to Penal Code section 667.5(c)(21).

10 Count 2

11 On or about January 22, 2021, in the County of San Luis Obispo, State of California, the  
12 crime of Assault To Commit A Felony During The Commission Of A First Degree Burglary  
13 in violation of PC220(b), a Felony, was committed in that KAMMERON ISAAC  
14 ANDERSON did during the commission of a first degree burglary assault [REDACTED] [REDACTED]  
15 (DOB 1/27/84), with the intent to commit rape, sodomy, oral copulation and a violation of  
16 sections 264.1, 288, and 289.

17 NOTICE: Conviction of this offense will require you to register pursuant to Penal Code  
18 section 290. Willful failure to register is a crime.

19 NOTICE: The above offense is a violent felony within the meaning of Penal Code 667.5(c).

20 NOTICE: Being charged with this criminal offense can result in mandatory pre-conviction  
21 HIV/AIDS testing and disclosure of the results to a victim and the Chief Medical Officer of  
22 the jail or prison facility where you are incarcerated pursuant to Penal Code Section  
23 1524.1 and Health and Safety Code section 121055 following a probable cause hearing  
24 resulting in a court order.

Count 3

On or about January 22, 2021, in the County of San Luis Obispo, State of California, the crime of Assault To Commit A Felony During The Commission Of A First Degree Burglary in violation of PC220(b), a Felony, was committed in that KAMMERON ISAAC ANDERSON did during the commission of a first degree burglary assault [REDACTED] (DOB 8/17/71), with the intent to commit rape, sodomy, oral copulation and a violation of sections 264.1, 288, and 289.

NOTICE: Conviction of this offense will require you to register pursuant to Penal Code section 290. Willful failure to register is a crime.

NOTICE: The above offense is a violent felony within the meaning of Penal Code 667.5(c).
