PC12022.7(a): Spec Alleg-Great Bodily Injury

It is further alleged as to Count 1 that in the commission of the above offense the said defendant, TERRI DEE BOYD, personally inflicted great bodily injury upon David Bristulf, not an accomplice to the above offense, within the meaning of Penal Code Section 12022.7(a) and also causing the above offense to become a serious felony within the meaning of Penal Code Section 1192.7(c)(8).

NOTICE: This offense is a serious felony and a violent felony within the meaning of Penal Code sections 1192.7(c)(8) and 667.5(c)(8)

Count 2

On or about October 15, 2019, in the County of San Luis Obispo, State of California, the crime of Battery With Serious Bodily Injury in violation of PC243(d), a Felony, was committed in that TERRI DEE BOYD did willfully and unlawfully use force and violence upon the person of David Bristulf, resulting in the infliction of serious bodily injury on such person.

NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c).


Count 3

On or about October 15, 2019, in the County of San Luis Obispo, State of California, the crime of Battery in violation of PC242, a Misdemeanor, was committed in that TERRI DEE BOYD did willfully and unlawfully use force and violence upon the person of Kellie Jean Myrich.
