The District Attorney of the San Luis Obispo County, California, hereby accuses the  
above named defendants of the following criminal offenses:

Count 1

1 On or about April 3, 2019, in the County of San Luis Obispo, State of California, the crime  
2 of Second-Degree Murder in violation of PC §187(a), a Felony, was committed in that  
3 ROBERT JOSEPH GARAY did unlawfully and with malice aforethought murder Daniel  
4 Fuentes, a human being.

5 **Count 2**

6 On or about April 3, 2019, in the County of San Luis Obispo, State of California, the crime  
7 of Voluntary Manslaughter in violation of PC §192(a), a Felony, was committed in that  
8 GABRIEL LUIS GARAY AND NATHANIEL ALEXANDER JARA did unlawfully, and without  
9 malice, aid and abet the killing Daniel Fuentes, a human being.

10 **Count 3**

11 On or about April 3, 2019, in the County of San Luis Obispo, State of California, the crime  
12 of Street Terrorism in violation of PC §186.22(a), a Felony, was committed in that  
13 ROBERT JOSEPH GARAY AND GABRIEL LUIS GARAY AND NATHANIEL ALEXANDER  
14 JARA did unlawfully and actively participate in a criminal street gang, to wit, Oceano  
15 13, with knowledge that its members engage in a pattern of criminal gang activity and did  
16 promote, further or assist in felony criminal conduct by gang members.

17 NOTICE: Conviction of this offense will require you to register pursuant to Penal Code  
18 section 186.30(a). Willful failure to register is a crime.
