20 The District Attorney of San Luis Obispo County, California, hereby accuses the
21 above named defendant of the following criminal offenses:

22 Count 1

23 On or about October 7, 2015, in the County of San Luis Obispo, State of California, the
24 crime of Possession Of Matter Depicting Minor Engaging In Sexual Conduct in violation of
25 PC311.11(A), a Felony, was committed in that JEFFREY PAUL GENTILE did knowingly
26 and unlawfully possess and control matter, to wit: Child Pornography the production of
27 which involved the use of a person under the age of 18 years, said defendant knowing that
28 the matter depicted a person under the age of 18 years personally engaging in and

1 simulating sexual conduct as defined in Penal Code Section 311.4(d). It is further alleged
2 that the matter contained more than 600 images and 10 or more images involving a
3 prepubescent minor and a minor who had not attained 12 years of age within the meaning
4 of PC311.11(c)(1).

5 NOTICE: Conviction of this offense will require you to register pursuant to Penal Code
6 section 290. Willful failure to register is a crime.

9 It is further alleged pursuant to Penal Code Section 1170(b)(2) that one or more of the
10 following factors in aggravation listed in California Rule of Court 4.421 may apply to the
11 defendant(s) or to conduct of the defendant(s):

12 4.421(a)(8) The manner in which the crime was carried out indicates planning,
13 sophistication, and professionalism.

14 4.421(a)(10) The crime involved a large quantity of contraband.
