Count 1

On or about January 9, 2018, in the County of San Luis Obispo, State of California, the

PC12022(b)(1): Spec Alleg-Use Of Deadly Weapon

It is further alleged as to Count 1 that in the commission of the above offense, the said defendant, ROBERT WILLIAM KOEHLER IV, personally used a deadly and dangerous weapon, to wit, a knife or sharp cutting instrument, said use not being an element of the above offense, within the meaning of Penal Code Section 12022(b)(1) and causing the above offense to be a serious felony within the meaning of Penal Code section 1192.7(c)(23).
