

24 Felony, was committed in that TIM PATRICK PRENDEVILLE did willfully, unlawfully, and  
25 lewdly commit a lewd and lascivious act upon and with the body and certain parts and  
26 members thereof of  a child under the age of fourteen years, with the intent of  
27 arousing, appealing to, and gratifying the lust, passions, and sexual desires of the said  
28 defendant and the said child.

Count 8

On or about October 5, 2019, in the County of San Luis Obispo, State of California, the crime of Indecent Exposure in violation of PC314.1, a Misdemeanor, was committed in that TIM PATRICK PRENDEVILLE did willfully, unlawfully, and lewdly expose his/her person, and the private parts thereof, in a public place, and in a place where there were present other persons to be offended and annoyed thereby.
