Footnote #	Footnote Narrative
1	A special use permit may be required if a fee is charged or money collected, alcohol and/or food is sold, the park will be used beyond its normal capacity or range of user activities, the proposed use is likely to infringe on other users, or the event will exceed 300 in attendance.
2	Swimming-Fees apply to swimming at the following county-owned pools: Santa Margarita Lake pool; Hardie Park pool; Shamel Park pool; CW Clarke Park pool; Templeton pool; and San Miguel pool.
3	Maximum rental 8 hours for ball field, 4 hours per week for tennis courts. Special Use Permit required for longer term rentals.
4	If the applicant, sponsoring organizations, staff, or performer has previously been involved in an event which required County to clean or repair the premises, the Parks & Recreation Department may prohibit subsequent use by any such organization.
5	Large Special Events, ie, Renaissance Festival, Triathlon, etc. Fees subject to negotiation and approval by Director--Parks & Recreation.
6	The County will provide a 50% discount off County Parks fees to valid California Distinguished Veteran passholders.
7	Fee collection may be temporarily waived by the Director--Parks & Recreation for a Parks fee if equivalent financial sponsorship is provided to offset revenue loss.
