

QUARTERLY REPORT OF INVESTMENTS QUARTER ENDING DECEMBER 31, 2019

DESCRIPTION

This is a summary of the Treasurer's investment operations for the quarter ending December 31, 2019, and a statement of compliance to the currently adopted County Treasurer's Investment Policy.

In addition, portions of the portfolio can be liquidated to meet any significant unexpected cash flow needs.

INVESTMENT

The investment portfolio as of the quarter ending December 31, 2019, was reviewed and found to be in compliance with the current County Treasurer's Investment Policy. The Treasury continues to maintain its conservative and prudent investment objectives, which in order of priority are safety, liquidity, and yield, while maintaining compliance with federal, state, and local laws and regulations.
