RE: Presidential Primary: No Party Preference Voters and Cross-Over Ballot

Notice and Application

The following parties have notified the Secretary of State, pursuant to Elections Code section 13102(c), that they will allow No Party Preference (NPP) voters to request their respective party's presidential ballot in the March 5, 2024, Presidential Primary Election:

- American Independent Party
- Democratic Party
- Libertarian Party

Elections Code section 13502(b) requires county elections officials to provide a notice to NPP voters receiving a nonpartisan ballot that they may request a ballot for a political party that is allowing cross-over voting in a presidential primary election. Additionally, Section 13502(e) requires the Secretary of State to provide county elections officials with a uniform application format for NPP voters to request a cross-over ballot.

For your convenience, we have created and attached an NPP Cross-Over Ballot Notice and Application. The notice and application comply with <u>Assembly Bill 292 (Pellerin)</u>, <u>Chapter 646, Statutes of 2023</u>, effective January 1, 2024, which informs NPP voters of the political parties allowing cross-over voting in the upcoming presidential primary election and is the application for them to request a one-time cross-over ballot.

## WHO CAN USE THIS APPLICATION

If you are not registered to vote with any political party and you would like to vote for a presidential candidate of a political party allowing cross-over voting in the presidential primary election, you may use this application to request a political party's ballot.

How to Fill Out this Application

**ITEM 1**. Affirm that you are registered to vote and have not disclosed a political party preference, and select the eligible political party whose ballot you would like to receive for the presidential primary election.

**ITEM 2.** Print your first, middle, and last names as they appear in your voter registration record.

**ITEM 3**. Print your date of birth in this order – month, day, year.

**ITEM 4**. Print the complete street address of your voting residence. A post office box or rural route cannot be accepted.

**ITEM 5.** Mailing address information must be completed by the voter. Print the complete address where you want your ballot sent if it is different than the residence address provided in Item 4.

**ITEM 6.** Sign and date in this order – month, day, year. No witness or notary required.

## **HOW TO SUBMIT THE APPLICATION**

Your No Party Preference Cross-Over Ballot Notice and Application must be returned to your county elections official in person, by mail, email, fax, or by other electronic means made available by the county elections official.

If this application is returned by mail, it must be returned directly to your county elections official.

Please do not send applications to the Secretary of State's office. Doing so will delay the application process.
