At its meeting on January 3, 2018, the Atascadero Basin Groundwater Sustainability Agency (the "Atascadero Basin GSA") Executive Committee authorized me to sign this Notice of Intent to initiate the development of a Groundwater Sustainability Plan (GSP) for the Atascadero Area Groundwater Sub-basin of the Salinas Valley Basin, Basin No. 3-004.11 (the "Atascadero Basin").

The Atascadero Basin GSA is the exclusive GSA for the Atascadero Basin and is submitting this notice in accordance with §10727.8 of the California Water Code and §353.6 of the Department of Water Resources' Emergency Regulations for Groundwater Sustainability Plans.

The Atascadero Basin GSA was formed under a memorandum of agreement between the County of San Luis Obispo, City of Paso Robles, City of Atascadero, Templeton Community Services District, Atascadero Mutual Water Company, Garden Farms Community Water District, Walnut Hills Mutual Water Company, Santa Ysabel Ranch Mutual Water Company, SMR Mutual Water Company, and the Atascadero State Hospital.

Interested parties may participate in the development of the Atascadero Basin GSP by attending the meetings of the Atascadero Basin GSA Executive Committee and/or any related public meetings and by participating in any public outreach and education programs and workshops undertaken as part of the stakeholder participation plan developed by the Atascadero Basin GSA. Additionally, the Atascadero Basin GSA Executive Committee includes positions for stakeholders in the Atascadero Basin including: Agricultural At-Large Member, Rural Residential At-Large Member, and Environmental At-Large Member. Any interested party living in the Atascadero Basin could apply to become a member. The Atascadero Basin GSA

DISCUSSION:

At the October 4, 2017 meeting of the Atascadero Basin Groundwater Sustainability Agency Executive Committee (EC), the EC discussed the requirement that the Atascadero Basin GSA adopt a Conflict of Interest Code in accordance with regulations set forth by the Fair Political Practices Commission and requested that steps be taken to designate the County of San Luis Obispo Office of the Clerk-Recorder as the *filing official*.

The Conflict of Interest Code for the Atascadero Basin GSA EC is attached for consideration and, once approved, will be submitted to the County Board of Supervisors ("code reviewing body") by March 9, 2018 pursuant to Government Code §87303.

RESOLUTION OF THE ATASCADERO BASIN GROUNDWATER SUSTAINABILITY AGENCY ADOPTING A CONFLICT OF INTEREST CODE

WHEREAS, the Political Reform Act, Government Code §81000 et seq. requires every state and local government agency to adopt and promulgate a Conflict of Interest Code pursuant to Government Code §87300; and,

WHEREAS, the Fair Political Practices Commission ("FPPC") has adopted a regulation which contains terms of a standard model Conflict of Interest Code (2 California Code of Regulations §18730), which is attached hereto by reference and will be amended to conform to amendments in the Political Reform Act after public notice and hearing conducted by the FPPC; and,

WHEREAS, the standard model Conflict of Interest Code will help ensure compliance by the Agency with the Political Reform Act.

NOW, THEREFORE, be it resolved and ordered by the Executive Committee of the Atascadero Basin Groundwater Sustainability Agency that:

- 1. The Conflict of Interest Code for the Atascadero Basin Groundwater Sustainability Agency is hereby adopted as set forth in Exhibit A attached to this Resolution.
- 2. Those officials and employees designated in Exhibit A, whether elected, appointed, or otherwise hired, shall file statements of economic interests, upon assuming office, leaving office, and during each year in office, with the County of San Luis Obispo Clerk-Recorder, as designated in Exhibit A, and the County Clerk-Recorder is the filing officer with the Fair Political Practices Commission pursuant to Government Code section 87500. In accordance with Government Code section 81008, the County Clerk-Recorder, as appropriate, shall make all statements retained available for public inspection and reproduction.

The Political Reform Act (Government Code Section 81000, et. seq.) requires state and local government agencies to adopt and promulgate conflict of interest codes. The Fair Political Practices Commission has adopted a regulation (2 California Code of Regulations Section 18730) that contains the terms of a standard conflict of interest code, which can be incorporated by reference in an agency's code. After public notice and hearing, the standard code may be amended by the Fair Political Practices Commission to conform to amendments in the Political Reform Act. Therefore, the terms of 2 California Code of Regulations Section 18730 and any amendments to it duly adopted by the Fair Political Practices Commission are hereby incorporated by reference. This regulation and the attached Appendices, designating positions and establishing disclosure requirements, shall constitute the conflict of interest code of the Atascadero Basin Groundwater Sustainability Agency (Agency).

Individuals holding designated positions shall file their statements of economic interests with the County of San Luis Obispo Clerk-Recorder, which will make the statements available for public inspection and reproduction. (Gov. Code Sec. 81008.) All statements will be retained by The County Clerk-Recorder. The County Clerk-Recorder will maintain the statements on the Agency's behalf which is located at 1055 Monterey Street, Suite D120, San Luis Obispo, CA 93408.

Such determination shall include a description of the consultant's or new position's duties and, based upon that description, a statement of the extent of disclosure requirements. The Agency's determination is a public record and shall be retained for public inspection in the same manner and location as this conflict of interest code. (Gov. Code Section 81008)

APPENDIX B – Disclosure Categories

- 2. Interests in real property located within the jurisdiction of the Agency, or within two miles of the jurisdictional boundaries of the Agency, or within two miles of any land owned or used by the Agency.
