





## Approach

### Address DWR-defined Corrective Actions

- 1. Provide justification for, and effects associated with, the sustainable management criteria for groundwater levels
- Develop Sustainable Management Criteria for the Depletions of Interconnected Surface Water based on best available information and science.

## Approach

### Corrective Action 1 – Groundwater Levels

- Describe the specific undesirable results GSAs aim to avoid.
- Disclose the anticipated impact of operating the Subbasin at conditions protective against those effects on relatively shallow domestic wells and all other beneficial uses and users.
- Using best available information, analyze locations and number of wells/well infrastructure that could be impacted by Subbasin management.
- Explain how the existing MTs are consistent with avoiding undesirable results.
- As needed, consider mitigation strategies for drinking water well impacts that may occur with continued overdraft.

## Approach

### Corrective Action 2 – Interconnected Surface Water

- Clarify and address the currently conflicting information in the GSP.
- If the GSAs cannot provide a sufficient, evidence-based justification for the absence of interconnected surface water, develop sustainable management criteria.
- Evaluate and disclose potential effects of the GSP's sustainable management criteria on beneficial uses of the interconnected surface water and on groundwater uses and users.






Representative monitoring wells with water level minimum threshold (MT) and measurable objective (MO)








Well location accuracy limits our ability to interpolate MT surface at existing well locations







## Approach: Interconnected Surface Water

**Riparian Vegetation** 

- Review mapped phreatophytes and wetlands
- Evaluate quantitative relationships among vegetation health, precipitation, stream flow and groundwater levels
- Select MT as depth to water empirically associated with reasonable vegetation health and survival

### **Aquatic Animals**

- Literature review and expert interviews to document recent historical presence of steelhead
- Steelhead passage day analysis under recent historical conditions and with MTs and GSP projects



Declining trend from 1998 to 2016, with minor increases in 2005 and 2012





Net decline 1998-2016, with brief but large highs in 2006 and 2011



# Water Level Evaluation for GDEs—1

- Phreatophytes sense the true water table in the alluvium, not the water level in deeper aquifers
- Few wells with water levels also have borehole or screen depth information
- Nested monitoring wells installed this year for SEP have really helped!




## Water Level Evaluation for GDEs-2


