## Permit Application – Multiple Animal Use / Limitation Extension

- All permitted operations must be conducted in accordance with Animal Services’ regulations and standards.
- All fees are non-refundable and must be remitted at the time of application. Make checks payable to **Animal Services Division**. Payment of the application fee neither constitutes nor guarantees permit approval. All permits are non-transferable.
- The effective period of all permits is one calendar year, beginning January 1. It is the responsibility of the permit holder to ensure that an application for renewal has been submitted to and received by Animal Services prior to the expiration of their current permit term. A late fee will be applied to applications received after January 1.
- Permit holders with multiple locations must submit an application for each location. Similarly, individuals intending to breed animals covered by a Non-commercial / Limitation Extension permit must also acquire a Hobby Breeder permit. A separate fee will be applied to each application.
