## Minutes:

- Frank Warren welcomed the stakeholder group at 3:00 p.m. All participants introduced themselves and Frank presented goals for meeting. Frank also reviewed the Stakeholder process, format and rules for the meeting (e.g. consensus voting, no rules of order, etc.)

- 3. Nestor went on to discuss the PEI Programs Timelines:

- 4. Mandee Poe was introduced and discussed the Student Assistance Program serving six middle schools throughout San Luis Obispo County. The PEI Team provides the following support:
  - A. Student Support Counseling
  - B. Family Advocates
  - C. Friday Night Live

- 5. Raven Lopez introduced her replacement Briana Hansen to the group, and went on to give the MHSA Fiscal Update:
  - FY 2017/18 Adopted Budget is \$15.7M (MHSA \$12.3M/Other Revenue \$3.4M)

CSS: \$12.MPEI: \$2.5MINN: \$635KWET: \$151K

- CFTN (Electronic Health Record Support): \$480K
- Prudent Reserve Balances:

CSS: \$2,745,458PEI: \$67,608

- Annual Adjustment: additional \$280K in one-time funds with July payment
